

ANNEX .ST - SPECIAL CONDITIONS FOR THE .ST (cc)TLD



In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .ST domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

Section .ST.1. Trustee authority and Registry

.ST is the official country code Top-Level-Domain (ccTLD) of São Tomé and Príncipe. The following diagram presents the various parties involved and the Trustee Authority for the .ST TLD:



You can view the information and special rules of each party involved by clicking on the respective links.

Section .ST.2. Registration terms and conditions

When You apply to register a .ST domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .ST domain names, as defined by Tecnisys, and which may be viewed at the following page: http://www.nic.st/terms_of_service

These contracts are binding between You and the .ST Registry. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully understood and accepted these rules on Our website.

Section .ST.3. Special requirements

.ST special requirements are available at: <http://www.gandi.net/domain/st/info>

.ST domain names are open to anyone.

You have to provide and maintain accurate, reliable and up-to-date personal contact information, failing this the Registry can delete Your domain name.

Section .ST.4. Registration term

The registration term is from 1 to 10 years. To avoid any deactivation of the domain name, the renewal must be paid and funds cleared **before the Expiration date**.

Section .ST.5. Pricing

One and two character domain names are subject to specific registration pricing as indicated on Our interface during Your order.

Section .ST.6. Storage of contact information

You accept that the .ST Registry can access Your personal contact information and display it in the public [Whois](#) database.

You can choose to do not disclosed some of Your personal data (except Your first and last name, and the organization name for legal persons) in the Whois database upon request to Our customer service department. In that case Your data will be replaced, in the Whois database, by Gandi's contact information specifically designed for this service.

Section .ST.7. Dispute resolution policy

The Registry has established a dispute resolution policy for .ST domain names that You agree fully abide by: <http://kb.registry.st/domains/domain-dispute>

Section .ST.8. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration),
- was created and transferred at least 60 days prior to the request.

The transfer's completion requires Your confirmation (by e-mail).

Upon successfully transferring a domain name, the registration period is extended by one year.

Section .ST.9. Ownership change

The ownership change process is available on Our Interface, it requires the confirmation of the two parties by e-mail. The owner change of a domain name does not change the domain's

Expiration date.

Section .ST.10. Deletion process

Upon the Expiration, the domain name is suspended (Hold) for 40 calendar days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain goes into Redemption Period for an additional 30 calendar days and all associated technical services are removed. The domain name can be restored in accordance with the terms and conditions described on Our website and/or by as

communicated by Our customer service department. **Attention during this period the .ST Registry may use the domain name for own purposes, sell it to a third party through auctions or any other way. It means that You do not have any priority to recover the management of the domain name and it can be recover by a third party via an auction process for example.**

If the domain is neither renewed nor restored within these deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name, which will become available for registration under the "first-come first-served" basis.
