

ANNEX .VG - SPECIAL CONDITIONS FOR THE .VG ccTLD



In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .VG domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

Section .VG.1. Trustee authority and Registry

.VG is the official country code Top-Level-Domain (ccTLD) of British Virgin islands. The following diagram presents the various parties involved and the Trustee Authority for the .VG TLD:



You can view the information and special rules of each party involved by clicking on the respective links.

Section .VG.2. Registration terms and conditions

When You apply to register a .VG domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .VG domain names, as defined by the .VG Registry and KSregistry / CentralNic, and which may be viewed at the following page:

This contract binds You to the .VG Registry and KSregistry / CentralNic. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully understood and accepted these rules on Our website.

KSregistry / CentralNic may, at any time and in its sole discretion, add, modify, revise or amend .VG rules. You acknowledge that, in accordance with the rules enacted by KSregistry / CentralNic,

publication of new or revised rules on the website <https://nic.vg> shall constitute due notice.

Section .VG.3. Special requirements

.VG special requirements are available at: <http://www.gandi.net/domain/vg/info>

.VG domain names are open to anyone.

You agree to provide and maintain accurate, reliable and up-to-date personal contact information, the failure to meet these requirements can lead to the deletion of Your domain name by the .VG Registry and KSregistry / CentralNic.

Some words are reserved, in particular names of geographic regions and names of officially recognized entities can be registered only upon the written consent of the relevant authority <https://nic.vg/terms.php> (3.6 and 3.7).

Section .VG.4. Registration term

The registration term is from 1 to 10 years. To avoid any deletion of the domain name, the renewal must be paid and funds cleared before the Expiration date.

Section .VG.6. Storage of contact information

You consent to the collection, use, copying, distribution, publication, in particular into the public [Whois](#) database if applicable, modification and any other processing of Your personal data by the Registry and KSregistry / CentralNic and their designees and agents for the purpose of providing domain name registration services and in accordance with applicable laws.

Section .VG.7. Dispute resolution policy

The .VG Registry has adopted the ICANN Uniform Dispute Resolution Policy (UDRP) for .VG domains, that You agree to fully abide by:

Section .VG.8. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the

transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend that You start the transfer request at least one month prior to its Expiration), and
- was last transferred over 30 days ago.

Upon successfully transferring a domain, the registration period is extended by one year.

Section .VG.9. Ownership change

The ownership change process is available on Our Interface and requires the confirmation of both parties by e-mail.

The owner change of a domain name does not change the Expiration date.

Section .VG.10. Deletion process

Upon the Expiration of the domain name, We suspend (Hold) the domain name for 45 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain name goes into Redemption Period for an additional 30 days. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

If the domain name is neither renewed nor restored within these deadlines, the Registry shall place the domain name in "Pending Delete" status for several days, and then delete the domain name, which will become available for registration on a "first-come first-served" basis.

Article .VG.11. Actions by KRegistry / CentralNic

You acknowledge and agree that KRegistry / CentralNic reserves the right to deny, cancel or transfer to a third party any domain name or transaction, as well as place any domain name under lock status in its unlimited and sole discretion in the following cases:

- to protect the integrity and stability of the .VG domain names system,
- to correct mistakes of KRegistry / CentralNic or any Registrar connected to the registration of a domain name
- to avoid any civil or criminal liability,
- to comply with court or binding arbitration orders,
- for non-payment of the applicable fees.

Article .VG.12. Your obligation of guarantee

In any case, You commit Yourself to indemnify, defend and hold harmless KRegistry / CentralNic, the .VG Registry and their subcontractors, as well as their officers, directors, employees, agents and affiliates from and against any claims, damages, liabilities, costs and expenses (including reasonable legal fees and expenses) arising from or relating to for any reason Your domain name. This guarantee shall prevail after the end of the present contract, whatever may be the cause, and is the direct consequence of Our accreditation agreement.
