

## ANNEX .AM - SPECIAL CONDITIONS FOR THE .AM ccTLD



In addition to Gandi's [General Terms and Conditions](#) of domain name registration, the registration and use of a .AM domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

### Section .AM.1. Trustee authority and Registry

.AM is the official country code Top-Level-Domain (ccTLD) of Armenia. AM domains are also used by people related to the AM Radio Station Industry. The following diagram presents the various parties involved and the Trustee Authority for the .AM ccTLD:

### Section .AM.2. Registration terms and conditions

When You apply to register a .AM domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .AM domain names, as defined by AMNIC, BRS Media and RRP Proxy / CentralNic, and which may be viewed at the following pages:

### Section .AM.3. Special requirements

.AM domain names are open to anyone.

You have to provide and maintain accurate, reliable and up-to-date personal contact information, otherwise the Registry may suspend or delete Your domain name.

### Section .AM.4. Registration term

The registration term is from 1 to 5 years. To avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 3 days before the Expiration date**.

### Section .AM.6. Storage of contact information

You consent to the use, copying, distribution, publication in particular in the public [Whois](#) database if applicable, modification and other processing of Your personal contact information by the Registry, BRS Media, RRP Proxy / CentralNic and data escrow agent designated by BRS Media for the purpose of providing domain name registration and management services and in accordance with applicable law.

### Section .AM.7. Dispute resolution policy

AMNIC has adopted the ICANN Uniform Dispute Resolution Policy (UDRP) for .AM domains, that You agree fully abide by.

### Section .AM.8. Transfer (change of Registrar)

To transfer a .AM domain name to Gandi, please contact Our customer service department. You will have to send Us a Letter of Authorization (LOA) by which the current owner authorizes the transfer to Gandi, signed with supporting documents, which Gandi will send to the Registry.

Upon successfully transferring a domain, the registration period is extended by one year.

### **Section .AM.9. Ownership change**

To change the ownership of a domain name, please contact Our customer service department. You will have to send Us a Letter of Authorization (LOA) by which the current owner authorizes the ownership change to a new registrant, signed with supporting documents which Gandi will send to the Registry.

The ownership change resets the expiration date of the domain name, and any remaining period is lost.

### **Section .AM.10. Deletion process**

**2 days before the Expiration date**, the domain name is released by Gandi to the Registry. All the associated technical services are deactivated.

At this time, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 28 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry shall delete the domain name, which will become available for registration under the "first-come first-served" basis.

### **Section .AM.11. Your warranty obligation**

You commit Yourself to indemnify, defend and hold harmless BRS Media, RRP Proxy / CentralNic and their subcontractors, and the directors, officers, employees, affiliates and agents of each of them, from and against any and all claims, damages, liabilities, costs and expenses, including reasonable legal fees and expenses, arising out of or relating to the registration of Your domain name. This indemnification obligation shall survive the termination of the present contract, whatever may be the cause.

### **Section .AM.12. Rights of BRS Media**

You expressly acknowledge and accept that BRS Media reserves the right to deny, cancel, transfer or otherwise make unavailable any domain name that it deems necessary, in its discretion :

- to protect the integrity and stability of the Registry and domain names system,
- to comply with any applicable laws, government rules or requirements, requests of law enforcement, in compliance with any dispute resolution process,
- to avoid any liability, civil or criminal, on the part of BRS Media, as well as its affiliates, subsidiaries or subcontractors, or the officers, directors, representatives, employees, or stockholders of any of them,
- for violations of the present contract or the rules established by BRS Media and RRP Proxy / CentralNic,
- to correct mistakes made by Registry or any registrar in connection with a domain name registration.

BRS Media also reserves the right to hold or lock a domain name during resolution of a dispute.
