

## ANNEX .AS - SPECIAL CONDITIONS FOR THE .AS ccTLD

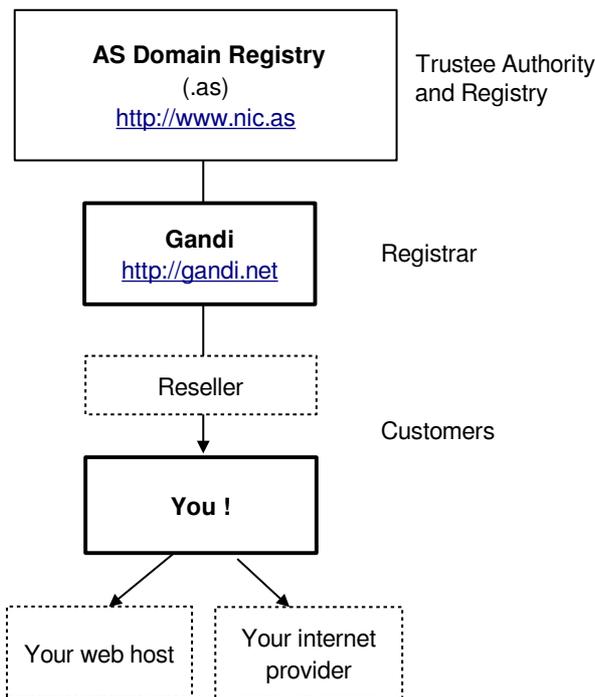

In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .GG or a .JE domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

### Section .AS.1. Trustee authority and Registry

.AS is the official country code Top-Level-Domain (ccTLD) of American Samoa. The following diagram presents the various parties involved and the Trustee Authority for the .AS ccTLD:



You can view the information and special rules of each party involved by clicking on the respective links.

### Section .AS.2. Registration terms and conditions

When You apply to register a .AS domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .AS domain names, as defined by Island Networks, and which may be viewed at the following page:

This contract is binding between You and the .AS Registry. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully understood and accepted these rules on Our website.

### Section .AS.3. Special requirements

.AS domain names are open to anyone.

In accordance with Registry rules, You agree to actively use Your domain name on the Internet, and provide and maintain accurate, reliable and up-to-date personal contact information, failing this the Registry can delete Your domain name.

### Section .AS.4. Registration term

The registration term is from 2 to 10 years and the renewal term is from 1 to 9 years. To avoid any deactivation of the domain name, the renewal must be paid and funds cleared **before the Expiration date**.

### Section .AS.6. Storage of contact information

You accept that the .AS Registry can access Your personal contact information and display it in the public [Whois](#) database.

### Section .AS.7. Dispute resolution policy

The .AS Registry has adopted the ICANN Uniform Dispute Resolution Policy (UDRP) that You agree fully abide by:

### Section .AS.8. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code supplied by Your current Registrar (if no auth code is supplied the transfer has to be approved by the losing Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend that you start the transfer request at least one month prior to its Expiration).

The transfer's completion requires Your confirmation (by e-mail).

Upon successfully transferring a domain name, the registration period remains unchanged.

### Section .AS.9. Ownership change

The ownership change process is available on Our Interface, it requires the confirmation of the two parties by e-mail.

The owner change of a domain name does not change the domain's Expiration date.

### Section .AS.10. Deletion process

**Upon the Expiration of the domain**, We suspend (Hold) the

domain name for 30 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain goes into Redemption Period for an additional 5 days, and all associated technical services are deactivated. It can only be restored during this period. in accordance with the terms

and conditions described on Our website and/or by as communicated by Our customer service department.

If the domain is neither renewed nor restored within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
