

In addition to Gandi's <u>General Terms and Conditions</u> for domain name registration, the registration and use of a . 닷컴 domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in Our <u>General Terms and Conditions</u> of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: http://www.gandi.net/admin/contracts/.

Section .닷컴.1. Trustee authority and Registry

.닷컴 (xn--mk1bu44c)is a generic Top-Level-Domain (gTLD) which means .com in Korean. The following diagram presents the various parties involved for the .닷컴 TLD:



You can view the information and special rules of each party involved by clicking on the respective links.

Section .닷컴.2. Registration terms and conditions

When You apply to register a .닷컴 domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .닷컴 domain names, as defined by ICANN and Verisign and which may be viewed at the following pages:

Section .닷컴.3. Launch rules

The . 닷컴 domain name launch will occur in 3 phases: Sunrise, Landrush and general opening.

The Sunrise phase will run from the 16th of May, 2016 to the 19th of June, 2016. The Priority Access phase is scheduled from the 20th of June, 2016 to the 15th of August, 2016. The Landrush phase is scheduled from the 16th of August to the 29th of August, 2016. General opening is scheduled for the 30th of August, 2016. These dates are not definitive and are subject to change by the Registry.

Preregistrations during both the Sunrise, the Priority Access Period, the Landrush and general opening phases are available at Gandi: domain names can be ordered at that time, but will not yet be registered or reserved.

Section .닷컴.4. Special requirements

.닷컴 domain names are open to anyone.

Section .닷컴.5. Sunrise

5.1 Eligibility rules

Only owners of a trademark registered with the trademark rights protection mechanism "TMCH" (Trademark Clearinghouse) established by ICANN are eligible to make a request during the Sunrise period.

As a TMCH trademark agent, Gandi can proceed with the registration of Your trademarks with TMCH (service reserved to Our Corporate customers, please contact Our <u>Corporate team</u>).

Eligibility conditions concerning the registration of a trademark with TMCH and the applicable rules are available at the following address: http://www.trademark-clearinghouse.com/downloads

Once Your trademark has been validated, TMCH generates one or several "labels" strictly identical to Your trademark.

Upon the submission of Your trademark with TMCH, You can choose the Sunrise service, provided that Your trademark has been validated by TMCH. The Sunrise service includes:

- generating a "SMD" (Signed Mark Data) file that proves the validation of Your trademark and allows You to make a registration request during the Sunrise period for one or several domain names strictly identical to the "label(s)" generated, provided that You comply with the eligibility conditions and rules enacted by the Registry,
- sending notifications (NORNs) that inform You of the registration of a domain name identical to Your trademark by a third party during the Sunrise period.

During Your registration request on Our interface, You must upload Your "SMD" file for verification.

5.2 Allocation rules

Sunrise applications are reviewed on a "first-come first-served" basis.

When a domain name is allocated to You in Sunrise period, the third parties that are the owners of an identical mark registered within TMCH are notified of Your registration.

5.3 Dispute resolution

Any dispute relative to the validation of Your trademark with TMCH must be submitted in accordance with the dispute resolution procedure established by TMCH:

Any dispute arising from the allocation of a domain name during the Sunrise period must be submitted in accordance with the dispute resolution procedure established by the Registry that You agree fully abide by:

5.4. Refund Conditions

In any case, You will not be entitled to receive any refund if Your application is rejected (eligibility criteria not met, "SMD" file invalid or revoked ...) or if the domain name is not granted to You (if a third party has successfully challenged the domain name registration ...).

Section .닷컴.6. Priority Access Period

6.1 Eligibility rules

The Godfathering period is restricted to current registrants of a second-level domain name (in ASCII or IDN script) in the .com top-level domain provided You have registered the domain name prior to the start date of the Godfathering period and that you have hold the second level domain name for longer than the Add Grace Period. Each applicant shall have the exclusive right during the Godfathering period to register the exact match of the existing .com second level domain name in any one or more of the Registry TLD's provided:

(I) such matching second level domain name is available for registration in such Registry TLD's during the Godfathering period (II) such matching second level domain name is registered through a Registrar that is the same Registrar-of-record for the existing .com second level domain name as of the time of the registration of the Matching Second Level Domain Name

In the event a transfer of an existing .com Second Level Domain Name to another Registrar (the gaining Registrar) is initiated (e.g for the purpose of a qualifying priority access program aapplicant registering the matching seconf level domain name through the gaining Registrar, Verigisn requires up to forty-eight (48) hours from the time the gaining Registrar becomes the registrar-of-records for the existing .com second level domain name for the transfer to be reflected in Verisign's systems as necessary for the qualifying priority access program applicant to be able to register the matching seconf level domain name.

6.2 Allocation rules

Godfathering applications are reviewed on a "first-come first-served" basis.

When a domain name is allocated to You in Priority Access period, the third parties that are the owners of an identical mark registered within TMCH are notified of Your registration.

6.3. Refund Conditions

In any case, You will not be entitled to receive any refund if Your application is rejected (eligibility criteria not met, "SMD" file invalid or revoked ...) or if the domain name is not granted to You (domain name granted to an other person during an auction, if a third party has successfully challenged the domain name registration ...).

Section .닷컴.7. Landrush

7.1 Eligibility rules

The Landrush is open to any eligible entity or individual for any available domain name in the Registry TLD during the Landrush Program.

7.2 Allocation rules

Landrush applications are reviewed on a "first-come first-served" basis.

When a domain name is allocated to You in Sunrise period, the third parties that are the owners of an identical mark registered within TMCH are notified of Your registration.

7.4. Refund Conditions

Each domain name registration in the Registry TLD during the Landrush is subject to an application fee, in addition to the initial registration fee. In any case, You will not be entitled to receive any refund if Your application is rejected (eligibility criteria not met, "SMD" file invalid or revoked ...) or if the domain name is not granted to You (domain name granted to an other person, if a third party has successfully challenged the domain name registration ...).

Section .닷컴.8. "Trademark Claim Notice" period

In accordance with ICANN rules, during the Godfathering and the Landrush period and 90 days upon general opening, a "Trademark Claim Notice" period will run.

During this period if the domain name for which You requested registration is identical to a trademark that is registered and validated with TMCH (according to the "labels" generated), You will receive a warning notice ("Trademark Claim Notice") in real time on Our interface informing You that a third party has rights to the domain name You requested.

You must confirm or cancel Your registration request, with full

knowledge of the notice and its consequences. It being specified that if You do not confirm the notice, Your request will not be sent to the Registry.

If You confirm Your registration request, third parties who own an identical mark are notified of Your registration.

For requests made in preregistration, beginning one day prior to the opening of the period concerned, Gandi will notify You by email of the "Trademark Claim Notice" and Your registration request will be put in "error" until You confirm or cancel Your registration via Our interface. It being specified that, in accordance with ICANN rules, if You do not confirm the notice, Gandi will not send Your registration request to the Registry upon the opening of the concerned period and cannot, in any case, be held liable for the non-registration of Your domain name and particularly if the domain name is registered by a third party who has validated the "Trademark Claim Notice" upon the opening of the period concerned.

It is Your sole and entire responsibility to confirm, if You want, all the notices received before the opening of the concerned period and the sending of Your request to the Registry.

Section . 닷컴 .9. Reserved names and premium domain names

Some words are reserved or prohibited:

http://www.icann.org/en/about/agreements/registries/xn--mk1bu44c (specification 5. schedule of reserved names), names containing two characters followed by two hyphens and names beginning or ending by a hyphen are not allowed.

The registration of "premium" domain names is not available on Our interface, You would need to contact Our customer service department for this.

For requests made in preregistration, if the domain name You have preregistered is a "premium" domain name, Your request will be put in "error" and You will be notify by email. Then You will be able to either pay the additional costs applicable to "premium" domain names in order to validate Your registration request or cancel Your request. It being specified that if You do not contact Our customer service department and do not pay the additional costs applicable to "premium" domain names, Your registration request will be not sent to the Registry.

Section .닷컴.10. Registration term

The registration term is 1 year for requests made during the Sunrise period, the Godfathering and the Landrush, and from 1 to 10 years for requests made during the general opening. To avoid any deactivation of the domain name, the renewal must be paid and funds cleared **before the Expiration date**.

Section .닷컴.11. Pricing

"Premium" domain names are subject to specific prices as displayed on Our website during Your order.

You acknowledge and agree that the Registry TLD will have nonuniform renewal pricing, such that the renewal fee for certain domain names in the Registry may be higher than the renewal fee for other domain names in the Registry TLD.

Moreover, You acknowledge that the renewal pricing of a premium

domain name may be higher than the standard pricing in compliance with the pricing set up by the Registry. Renewal pricing can be communicated upon request to Our support team at support-en@support.gandi.net

Section .닷컴.12. Storage of contact information

In application of ICANN contracts, all personal and technical information associated with the registration of Your domain name is recorded and made available to ICANN and IRON MOUNTAIN (ICANN's designated Registrar Data Escrow agent), in addition to messages pertaining to each registration or modification, during the entire duration of the registration of the domain name, plus the two following years.

You accept that the Registry can access Your personal contact information and display it in the public Whois database.

You give Your consent to Verisign to collect, use store, access, transfer, disclose, and/or process of the Service data as instructed by Registrar and/or as necessary for Verisign to perform the Verisign services in accordance with the Registry policies.

You agree to release Verisign from any and all claims, damages, liability, costs and expenses due to Verisign's collection, use, storage, access, transfer, disclosure and/or processing of the service data as instructed by Registrar and/or as necessary for Verisign to perform the Verisign Services in accordance with this agreement and the Registry policies.

You agree that this section survives the termination or expiration of this agreement.

Section .닷컴.13. Dispute resolution policy

The Registry has adopted the ICANN dispute resolution procedures UDRP (Uniform Dispute Resolution Policy) and URS (Uniform Rapid Suspension System) for .닷컴 domains, that You agree fully abide by.

Section .닷컴.14. Transfer (change of Registrar)

The transfer-in process may be initiated on Our Interface. Before requesting the transfer of the domain, please make sure You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- · does not have a TransferProhibited status,
- does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration),
- · was created at least 60 days prior to the request,
- has not been transferred within the last 60 days.

The transfer's completion requires Your confirmation (by e-mail).

Upon successfully transferring a domain, the registration period is extended by one year.

Section .닷컴.15. Ownership change

The ownership change process is available on Our Interface and requires the confirmation of both parties by e-mail.

The owner change of a domain name does not change the domain's expiration date.

Section .닷컴.16. Deletion process

Upon the Expiration of the domain, We suspend (Hold) the domain name for 45 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain goes into Redemption Period for an additional 30 days, and all associated technical services are deactivated. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

If the domain is neither renewed nor restored within these deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name, which will become available for registration on a "first-come first-served" basis.

Section .닷컴.17. Registrant representations and guarantees

You agree to provide and maintain accurate, reliable and up-to-date personal contact information. Failing to do so, the Registry may delete Your domain name.

By submitting a registration or modification request You acknowledge that:

- Your request must contain true, accurate and up-to-date information, must be made in good faith, for a lawful purpose, and must not infringe the rights of any third party,
- You have to participate in good faith in any proceedings as established by the Registry and ICANN,
- You have to accept and abide by the rules and policies enacted by the Registry.
- You must register and use all domain names applied for, or registered to You, only for legal purposes
- You must comply with any law or regulation or any rule, order, directive, or subpoena of any government jurisdiction and any Intellectual Property Rights or other third party right

In addition, by submitting a request during the Sunrise period, You acknowledge that the Registry and/or its agents are authorized to share information relating to Your request to TMCH, other Sunrise applicants, and/or any third party.

In any case, You acknowledge and agree that distributing malware, abusively operating botnets, phishing, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise engaging in activity contrary to applicable law are expressly prohibited. Failing to comply with this provision, You expose Yourself to the suspension of Your domain name, in addition to the prosecution for the prejudice caused to third parties and to the penalties mentioned under applicable law.

You also acknowledge and agree that distributing malware, abusively operating botnets, phishing, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise engaging in activity contrary to applicable law are expressly prohibited. Failing to comply with this applicable law, You expose Yourself to the suspension of Your domain name, in addition to the prosecution for the prejudice caused to third parties and to the penalties mentioned under applicable law. This section will survive the termination or expiration of this agreement.

You commit Yourself (within 30 days of demand) to indemnify and hold harmless the Registry, its affiliates and subsidiaries, as well as each of their respective owners, directors, managers, officers, employees, contractors, service providers and agents from and against any and all claims, damages, liabilities, costs, and expenses, including reasonable legal fees and expenses (including on appeal) arising out of or relating in any way to Your domain name, including, without limitation, the choice, registration, renewal, deletion, transfer or use of Your domain name and/or the violation of any applicable terms and conditions governing the registration of a domain name. You shall not enter into any settlement or compromise of any such claim without Gandi's prior written consent that shall not be unreasonably withheld. This indemnification obligation shall survive the termination of the present contract, whatever may be the cause, and is the direct consequence of Our accreditation agreement.

Section . 닷컴 .18. Exclusion of liability and actions of the Registry

You expressly acknowledge and accept that the Registry shall be entitled, that it deems necessary, in its sole and entire discretion, but not obligated, to reject, delete, suspend, transfer to a third party or place in "lock" status, "hold" status or similar status Your domain name:

- to correct any domain name registration mistakes made by the Registry or the Registrar
- to protect against imminent and substantial threats to the security and stability of the Verisign SRS
- pursuant to any legal order or subpoena of any government, or administrative or governmental authority or court of competent jurisdiction, or as otherwise specified for one or more Registry TLDs as set forth in the Registry Policies or an order documents
- to respond to a report from ICANN pursuant to section 6.3 of specification 6 (Name Collision Report Handling) of the Registry Agreement as determined by Verisign
- to comply with specifications adopted by any industry group generally recognized as authoritative with respect to the Internet (I.e) RFCs
- in the event You breach any of the provisions of this registration agreement
- in the event the TMCH reports fraud in an SMD file

You acknowledge that this section survives the termination or expiration of this agreement.

The Registry also reserves the right to place Your domain name in « lock » status, « hold » status or similar status during resolution of a dispute.

In addition, in the context of registration during the Sunrise period, You expressly acknowledge and accept that the Registry shall be entitled, but not obligated, to reject Your request or to delete, suspend, or transfer to a third party Your domain name if the Registry receives notice that Your "SMD" file is under dispute.

It is not the obligation of the Registry to notify You in advance of the termination or expiration for any reason of Your domain name and particularly they shall be entitled, but not obligated, to immediately suspend or delete Your domain name that is in breach of the Registry terms and conditions or any other applicable law or regulation.

You agree that You may not claim any compensation for damages of any sort from the Registry such as, but not limited to, any fees payable or paid within the context of a dispute initiated against any decision of the Registry.
