

## ANNEX .RU/.PФ - SPECIAL CONDITIONS FOR THE .RU and .PФ ccTLDs

version 4.1 – October 2nd, 2019

In addition to Gandi's [General Terms and Conditions](#) of domain name registration, the registration and use of a .RU or a .PФ domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in our [General Terms and Conditions](#) of domain name registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

### **Section .RU/.PФ.1. Trustee authority and Registry**

.RU is the official country code Top-Level-Domain (ccTLD) of Russia and .PФ (.XN--P1AI) is the official IDN ccTLD of Russia. The following diagram presents the various parties involved for the .RU and .PФ ccTLDs:

### **Section .RU/.PФ.2. Registration terms and conditions**

When You apply to register a .RU or a .PФ domain name, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .RU and .PФ domain names, as defined by RU Coordination Center and RU-Center, and which may be viewed at the following pages:

These policies, that You acknowledge to have fully understood and to have accepted via Our website bind You to RU Coordination Center and RU-Center. The present special conditions do not replace these rules, which are incorporated by reference, and are binding on Gandi and You.

### **Section .RU/.PФ.3. Special requirements**

.RU and .PФ domain names are open to anyone.

Domain names in **.PФ are only available in Cyrillic characters**. However, IDN (Internationalized Domain Names) are not available for .RU domain names.

### **Registration procedure**

To register a .RU or a .PФ domain name, please indicate:

- Full name of the holder (abbreviations are not allowed), and for legal persons the first name and last name of the official representative,
- for individuals: Your passport number, its issue date and the issuing authority (including country) and Your birth date,
- for legal persons: Your incorporation number (if You are located in Russia, Your Taxpayer identification number (TIN) and Territory-

linked taxpayer number (KPP)), and the address associated to Your Gandi account must correspond to Your legal address.

The nameservers (DNS) must be correctly configured for the associated domain name, such that they pass the zone check of RU-Center.

### **Verification procedure**

At any time, RU-Center may contact You (via Gandi or directly) for a verification request of Your personal data and require clarification and/or additional documents.

During the time of the verification procedure, RU-CENTER may suspend Your requests relative to the management of Your domain name and in particular any request of transfer, change the owner, or perform an early deletion.

Failing to answer within a deadline of 7 days, or if the personal data that You have registered are inaccurate, RU-CENTER may refuse any operation on Your domain names (in particular renewals), suspend, or delete Your domain names, and refuse any new registration.

### **Section .RU/.PФ.4. Registration term**

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and funds cleared no later than 3 days before the Expiration date.

### **Section .RU/.PФ.6. Storage of contact information**

You consent to the use, copying, distribution, publication, in particular in the [Registry](#) and [RU-Center](#) public Whois databases if applicable, modification and other processing of Your personal data by the Registry and RU-Center, and their designees and agents for the purposes of providing domain name registration services and in accordance with their privacy policy.

All personal and technical information as well as all data about modification associated with a domain name is recorded by the Registry during the entire duration of the registration of the domain name, plus the 25 following years.

### **Section .RU/.PФ.7. Dispute resolution policy**

The Registry does not have any particular dispute resolution procedure in place concerning .RU and .PФ domain names. However, in the event of a complaint, You must comply with the following rules:

### **Section .RU/.PФ.8. Transfer (change of Registrar)**

The transfer-in process may be initiated on Our website. In any case, after having initiated the transfer request, please contact Our customer service department.

In case of a transfer from an accredited Registrar other than RU-CENTER an authorization code (supplied by Your current Registrar) is required.

In case of a transfer from RU-CENTER or a RU-CENTER partner the procedure is manual and requires supporting documents.

Before any request, please be sure that:

- Your domain name does not expire soon (We recommend that you start the transfer request at least one month prior to its Expiration),
- the last transfer and the last owner change have been done since more than 30 days (in case of transfer between RU-Center and a RU-Center Partner or between RU-Center Partners, in principle these deadlines do not apply).

The transfer of a .RU or a .PΦ domain name does not change the domain name Expiration date.

#### **Section .RU/.PΦ.9. Ownership change**

Owner changes are **not available on Our website**, please contact Our customer service department. The procedure requires supporting documents.

Before any request, please be sure that:

- Your domain name does not expire soon (We recommend that you start the owner change request at least one month prior to its Expiration),
- the last transfer and the last owner change were done sooner than 30 days prior.

The owner change of a .RU or a .PΦ domain name does not change the domain name Expiration date.

#### **Section .RU/.PΦ.10. Deletion process**

**2 days before the Expiration date**, the domain name is removed by Gandi and is placed in Quarantine status for 30 days. At this time, all the associated technical services are deleted and the domain name may be restored in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

If the domain name is neither renewed nor restored within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
