

In addition to Gandi's General Terms and Conditions for domain name registration, the registration and use of a .AI domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our website. Capitalized terms have the definition attributed to them in Our General Terms and Conditions of domain name registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

#### Section .Al.1. Trustee authority and Registry

.AI is the official country code Top-Level-Domain (ccTLD) of Anguilla. The following diagram presents the various parties involved and the Trustee Authority for the .AI TLD:

#### Section .Al.2. Registration terms and conditions

When You apply to register a .AI domain name, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .Al domain names, as defined by the Registry and which may be viewed at the following page:

### Section .Al.3. Special requirements

.Al domain names are open to anyone.

Domain names are activated within 3 hours after registration.

You have to provide and maintain accurate, reliable and up-to-date personal contact information, failing this the Registry may suspend and/or delete Your domain name.

#### Section .Al.4. Registration term

The registration term is 2 years. To avoid any deactivation of the domain name, the renewal must be paid and funds at the later the day of the Expiration.

# Section .Al.7. Dispute resolution policy

The Registry has adopted the ICANN Uniform Dispute Resolution Policy (UDRP) for .AI domain names, that You agree fully abide by.

### Section .Al.8. Transfer (change of Registrar)

The process is started on Our interface. Before requesting the transfer of the domain name, please be sure that :

- You have the domain name authorization code (supplied by Your current Registrar),
- Your domain name does not have a TransferProhibited status.
- Your domain name does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration).

Upon successfully transferring a domain name, the registration

period is extended by one year.

#### Section .Al.8. Ownership change

The ownership change process is available on Our interface, it requires the confirmation of the two parties by e-mail.

The owner change of a .AI domain name does not change the Expiration date of the domain name.

### Section .Al.9. Deletion process

One day after Expiration, the domain name is suspended for 30 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this

period.

Then the domain name goes into Redemption Period for an additional 59 days. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or by as communicated by Our customer service department.

If the domain name is neither renewed nor restored within these deadlines, it will go to auction at <a href="http://auction.whois.ai">http://auction.whois.ai</a> (on the next 3rd Friday of the month at noon Anguilla time). These auctions will go for about 10 days but late bidding can extend it some. If the domain name has not been registered during the auction process, then it will become available for registration under the "first-come first-served" basis.
