

In addition to Gandi Corporate Special Conditions and Gandi's General Terms and Conditions for domain name registration, the registration and use of a domain name in the extensions mentioned above imply the acceptance of and compliance to the present special conditions contained herein.

All legal information and contracts are presented to You at the time of the subscription to Our Services. Capitalized terms have the definition attributed to them in Our General Terms and Conditions of domain name registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

## Description of the service

In the framework of its Gandi Corporate service, Gandi allows You to register Your domain name in the additional extensions mentioned above only available to Our Gandi Corporate customers, via one of Our partners, LatinTLD. The following diagram presents the various parties involved in the providing of this service:



When You apply to register a domain name in one of the proposed extensions, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of the extension chosen, as defined by the Trustee Authority and/or the Registry concerned. These contracts are binding between You and the Trustee Authority and/or the Registry. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully understood and accepted these rules.

In accordance with Our Contracts, You agree to provide and maintain accurate, reliable and up-to-date personal contact information, failing this, the Registry concerned can delete Your domain name or refuse its registration. You also accept that the Registry and LatinTLD can access Your personal contact information and display it in the public Whois database.

The registration of a domain name in the proposed extensions is usually done manually by the Registry concerned. The validation and processing time of Your application by the Registry can therefore vary from several hours to several weeks depending on the extension chosen.

For extensions that require a local presence, if You do not meet this condition, Our partner, LatinTLD, offers this local presence by placing itself as the owner and/or administrative contact at the Registry. Generally, LatinTLD places itself as administrative contact at the Registry in order to manage the domain names.

The .Al Registry, the official extension of Anguilla, is the Government of Anguilla.

- A Landrush phase will run from November 25th 2019 to January 23rd 2020. During this phase, domain names are not
  allocated under the first come first served basis. Domain names will be allocated at the end of the Landrush phase. If several
  applicants have requested the same domain name, a draw between all the applicants will assign the domain name. In case the
  domain name is not allocated to You, You will be not entitled to receive any refund. All registration requests made between
  these dates will be subject to Landrush phase. If You want to make a registration for general opening You will have to wait the
  end of the Landrush phase.
- The general opening will occur February 23rd 2020. At this time domain names will be available under the first come first served basis. All registration requests made between the end of the Landrush and the beginning of the general opening, will be stored and sent to the Registry only at the time of the beginning of the general opening.

The registration and renewal term is 1 year.

During this period, the Registry has the right to temporarily activate the domain name (for the application received in first), without any commitment by the Registry to accept the application. The registry will assign the domain name after this period, unless if there are several pending applications for the same domain name which would be subject to the .CL dispute resolution procedure.
