

In addition to Gandi's <u>General Terms and Conditions</u> of domain name registration, the registration and use of a .IM domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in our <u>General Terms and Conditions</u> of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

Section .IM.1. Trustee authority and Registry

.IM is the official country code Top-Level-Domain (ccTLD) of the Isle of Man. The following diagram presents the various parties involved and the Trustee Authority for the .IM TLD:

Section .IM.2. Registration terms and conditions

When You apply to register a .IM domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .IM domain names, as defined by the Registry Domicilium, and which may be viewed on:

Section .IM.3. Special requirements

.IM domain names are open to anyone.

Some words are not available to registration:

- words included on the .IM Black List (this list is not public), undesirable words, and words which are connected to regulated activities on the Isle of Man. Applicants for a domain name that is rejected for these reasons may appeal within 10 days of the rejection notice, stating the reasons why the name should be approved, by selecting the appeal process available on the .IM Registry website,
- names containing two characters followed by two hyphens and names beginning or ending by a hyphen.

Moreover, please note that:

- You have to provide and maintain accurate, reliable and up-todate personal contact information. Failing to do so, the Registry may delete Your domain name,
- in some instances the Registry may request certain information from You regarding Your legal identity when You make an application for or seek to amend the registration of a domain name,
- the Registry reserves the right to check Your application for compliance with the rules either before or after Your domain name is registered or renewed,
- the Registry reserves the right to refuse the registration of domain names and revoke domain names at the request of a competent authority.

Section .IM.4. Registration term

The registration term is from 1 to 2 years. To avoid any deactivation of the domain name, the renewal must be paid and funds cleared **before the Expiration date**.

1 and 2 character domain names are subject to a specific pricing as indicated on Our interface during Your order.

Section .IM.6. Storage and use of personal data

You accept that the Registry can access to Your personal data and display them in a public Whois database.

Section .IM.7. Dispute resolution policy

The Registry has set forth a specific .IM domain name Dispute Resolution Policy (IM DRP), that You agree fully abide by: https://www.nic.im/public/disputeresolution.mth

Section .IM.8. Transfer

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- · does not have a TransferProhibited status.
- does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration).

The transfer's completion requires Your confirmation (by e-mail).

The transfer of a domain name does not change the domain's expiration date.

Section .IM.9. Ownership change

The ownership change process is available on Our Interface and requires the confirmation of both parties by e-mail.

The owner change of a domain name does not change the domain's expiration date.

Section .IM.10. Deletion process

Upon the Expiration of the domain name, the domain name is suspend (Hold) for 30 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

If the domain is not renewed within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
