

In addition to Gandi's <u>General Terms and Conditions</u> for domain name registration, the registration and use of a .ME domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in Our <u>General Terms and Conditions</u> of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: http://www.gandi.net/admin/contracts/.

Section .ME.1. Trustee authority and Registry

.ME is the official country code Top-Level-Domain (ccTLD) of Republic of Montenegro. The following diagram presents the various parties involved and the Trustee Authority for the .ME TLD:

When You apply to register a .ME domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .ME domain names, as defined by doMEn d.o.o., and which may be viewed at the following page:

This contract is binding between You and the .ME Registry. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully

understood and accepted these rules on Our Website.

Section .ME.3. Special requirements

.ME domain names are open to anyone.

To register for a .ME domain name, You must abide by the following conditions:

- the registration term is 1 up to 10 years,
- to avoid any deactivation of the domain name, the renewal must be paid and funds cleared at least 1 day before the Expiration date,
- some words are reserved or prohibited: http://www.domain.me/policies#Reserved-Premium-Names,
- names containing two characters followed by two hyphens are not allowed.

Gandi does not manage third level domains (as net.me or co.me), the auctioning system, nor reserved Premium domain names.

Section .ME.4. Storage of contact information

You accept that .ME Registry can access to Your personal data and display them in a public Whois database.

Section .ME.7. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- · does not have a TransferProhibited status,
- · does not expire soon (We recommend to start the transfer request at least one month before Expiration),
- · was created at least 60 days prior to the request, or transferred at least 60 days prior to the request.

The transfer's completion requires your confirmation (by e-mail).

Upon successfully transferring a domain, the registration period is extended by one year.

The ownership change process is available on Our Interface.

The owner change of a .ME domain name does not change the domain's Expiration date.

Section .ME.9. Deletion process

Upon the Expiration of the domain, We suspend (Hold) the domain name for 30 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then, the domain name is placed on Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 30 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name, which will become available for registration under the "firstcome first-served" basis.
