

ANNEX .NU - SPECIAL CONDITIONS FOR THE .NU ccTLD



In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .NU domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

Section .NU.1. Trustee authority and Registry

.NU is the official country code Top-Level-Domain (ccTLD) of Niue. The following diagram presents the various parties involved and the Trustee Authority for the .NU TLD:

Section .NU.2. Registration terms and conditions

When You apply to register a .NU domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .NU domain names, as defined by WorldNames, and which may be viewed at the following pages:

fully understood and accepted these Rules on Our Website.

Section .NU.3. Special requirements

.NU domain names are open to anyone.

To register a .NU domain name, You must agree to adhere to the following conditions:

- the registration term is from 2 to 5 years,
- to avoid any deactivation of the domain name, the renewal must be paid and funds cleared **before the Expiration date**,
- provide and maintain accurate, reliable and up-to-date personal contact information, failing this the .NU Registry can delete Your domain name,
- names containing two characters followed by two hyphens are not allowed.

Gandi does not provide .NU domain names with only 1 or 2 characters or 3 numeric characters.

Section .NU.7. Transfer (change of Registrar)

Transfers are not available in Our Interface, please contact Our customer service department. You shall have to send Us a transfer [form](#).

Before requesting the transfer of the domain, please be sure that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend that you start the transfer request at least one month prior to its Expiration),
- was created at least 60 days prior to the request.

Upon successfully transferring a domain, the registration period is

extended by one year.

Section .NU.8. Ownership change

Owner changes are **not available on Our Website**, please contact Our customer service department.

The procedure consists in sending a change owner [form](#) by the current owner and a registration [form](#) by the new owner.

The owner change does not include any renewal. The creation date is reset at the Registry, and any remaining period is lost.

Section .NU.9. Deletion process

Upon the Expiration of the domain, We suspend (Hold) the domain name for 44 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

If the domain is not renewed within these deadlines, the Registry will delete the domain name, which will become available for registration on a “first come first served” basis.
