In addition to Gandi's General Terms and Conditions for domain name registration, the registration and use of a .NU domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our website. Capitalized terms have the definition attributed to them in Our General Terms and Conditions of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

.NU domain names are open to anyone.

To register a .NU domain name, You must agree to the following conditions:

- · the registration term is from 1 to 10 years,
- to avoid any deletion of the domain name, the renewal must be paid and funds cleared no later than 2 days before the **Expiration date**,
- provide and maintain accurate, reliable and up-to-date personal contact information, failing this the .NU Registry and IIS can delete Your domain name.
- names containing two characters followed by two hyphens are not allowed.

During Your registration request on Our Interface, You shall have to provide:

- if You are an individual, Your ID number (passport number ...),
- You are a legal person, Your registration number (corporate/business number...).
- in addition, if You are a legal person located inside the European Union but outside Sweden, Your VAT number (if applicable).

# Section .NU.7. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration).

The transfer's completion requires Your confirmation (by e-mail).

The transfer of a .NU domain name does not change the domain's Expiration date.

# Section .NU.8. Ownership change

Owner changes are not available on Our Website and require the sending of a form with proofs of identity, please contact Our customer service department.

The owner change of a .NU domain name does not change the domain's Expiration date.

#### Section .NU.9. Deletion process

1 day before the Expiration date, the domain name is released by Gandi to the Registry. All associated technical services are deactivated.

At this time, the domain name is placed on Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 60 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name,
