#### Section .PL.4. Registration term

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and funds cleared at least 2 days before the Expiration date.

If the domain name is not renewed within the deadline, the domain name will be deleted by the Registry and will become available for registration on a "first-come first-served" basis.
