

In addition to Gandi's <u>General Terms and Conditions</u> for domain name registration, the registration and use of a .CO.COM domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in Our <u>General Terms and Conditions</u> of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: http://www.gandi.net/admin/contracts/.

Section .CO.COM.1. Trustee authority and Registry

.CO.COM is a sub-extension of .COM for the Colombia zone, .CO.COM can also be used as a generic extension. The following diagram presents the various parties involved and the Trustee Authority for the .CO.COM TLD:

When You apply to register a .CO.COM domain name, You acknowledge that You have fully understood, and that You certify

Section .CO.COM.3. Special requirements

.CO.COM domain names are open to anyone.

To register a .CO.COM domain name, You must agree to the following conditions:

- the registration term is from 1 to 10 years,
- to avoid any deactivation of the domain name, the renewal must be paid and funds cleared before the Expiration date,
- provide and maintain accurate, reliable and up-to-date personal contact information, failing this the Registry can delete Your domain name.
- the registration of "premium" domain names is not available on Our interface, You would need to contact Our customer service department for this,
- names containing two characters followed by two hyphens are not allowed.

"Premium" domain names are subject to specific prices that will be communicated by Our customer service department upon request.

Section .CO.COM.5. Storage of contact information

You consent to the use, copying, distribution, publication in particular in the public <u>Whois</u> database, modification and other processing of Your personal data and/or any other information by Gandi, the Registry and CentralNic, and their designees and agents (including data escrow agents) in a manner consistent with the purposes of providing domain names registration services or to comply with law enforcement or any applicable law.

However You can opt-out of disclosing some personal information from this public database.

Section .CO.COM.6. Dispute resolution policy

The Registry has adopted the ICANN dispute resolution procedures UDRP (Uniform Dispute Resolution Policy) and URS (Uniform Rapid Suspension System) for .CO.COM domains, that You agree fully abide by.

Section .CO.COM.7. Transfer (change of Registrar)

The transfer-in process may be initiated on Our Interface. Before requesting the transfer of the domain, please make sure You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- · does not have a TransferProhibited status.
- does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration),
- · was created at least 60 days prior to the request,
- · has not been transferred within the last 60 days.

The transfer's completion requires Your confirmation (by e-mail).

Upon successfully transferring a domain, the registration period is extended by one year.

Section .CO.COM.8. Ownership change

The ownership change process is available on Our Interface, it requires the confirmation of the two parties by e-mail.

The owner change of a .CO.COM domain name does not change the domain's Expiration date.

Section .CO.COM.9. Deletion process

Upon the Expiration of the domain, We suspend (Hold) the domain name for 45 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 30 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name, which will become available for registration under the "first-come first-served" basis.
