

In addition to Gandi's <u>General Terms and Conditions</u> for domain name registration, the registration and use of a .DK domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in Our <u>General Terms and Conditions</u> of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: http://www.gandi.net/admin/contracts/.

#### Section .DK.1. Trustee authority and Registry

.DK is the official country code Top-Level-Domain (ccTLD) of Denmark. The following diagram presents the various parties involved and the Trustee Authority for the .DK TLD:



You can view the information and special rules of each party involved by clicking on the respective links.

## Section .DK.2. Registration terms and conditions

When You apply to register a .DK domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .DK domain names, as defined by DK Hostmaster, and which may be viewed at the following pages:

These contracts are binding between You and the .DK Registry. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully understood and accepted these rules on Our website.

#### Section .DK.3. Special requirements

.DK domain names are open to anyone.

To register a .DK domain name, You must adhere to the following conditions:

- provide and maintain accurate, reliable and up-to-date personal contact information, failing the .DK Registry can delete Your domain name.
- the Registry checks the email address validity, You must provide an email address not related to the domain name requested, valid and perennial that You consult regularly. If Your email address is not valid, the Registry can delete Your domain name.
- at any time, the .DK Registry may request You to send a
  declaration, within a deadline of 30 days, warranting that the
  registration and the use of Your domain name do not infringe
  third party's rights (in particular trademark rights...) and are not
  contrary to Danish legislation. Failing the Registry can delete
  Your domain name or assign it to another person (General
  Conditions 10.3.2),
- the .DK Registry can request You documents proving the legality of the registration and the use of Your domain name and/or block, suspend, delete Your domain name, or assign it to another person, particularly, in case of breach of registration rules and/or of Danish legislation, of confusion with identity, domain name, website or trademark of a third party, of phishing, of typosquatting, or of repeated violation of good domain name practice,

- names containing two characters followed by two hyphens are not allowed,
- Gandi does not provide the Registry VID (Very Important Domain) service.

Under the Registry rules, You do not acquire property rights of the domain name registered but rather that You are granted user rights of the domain name.

## **Technical requirements**

Your registration application must specify at least 2 name servers (DNS) approved by the Registry, You can:

- · indicate Gandi's DNS (approved by the Registry) or,

The .DK Registry checks if the DNS specified in the registration application are correctly configured for the domain name, according to the Registry's "zonecheck" standards.

If you want change Your DNS, they must also be approved by the Registry, then please fill out the DNS change <u>form</u> on line. The Registry will request You a confirmation, by email.

The name server host names must not be stated as CNAMEs for other host names.

# Registration

During Your registration request on Our website, if You are a legal person, You shall have to provide:

- · Your CVR number if You are located in Denmark,
- · Your VAT number for other persons.

# Verification procedure

In accordance with the Danish Act on Internet Domains (domæneloven) the Registry has to verify the personal contact information of contacts associated to .DK domain names:

The verification is handled directly by the Registry.

# Verification procedure for contacts in Denmark

The Registry verifies Your name (first/last name or name of the legal person) and address with the information in the Danish Civil Registration Register (CPR-register) for individuals or in the

Danish Central Business Register (CVR-register) for legal persons:

- for legal persons, the Registry will use Your CVR number for validate Your information,
- for individuals, the Registry will check the matching of Your information with the information in the Danish Civil Registration Register.

The Registry will contact You by email if it fails to validate Your information as described above. You will be able to provide additional information or correct, via the Registry website, the information You have declared during Your registration request. The Registry may request You to provide information including the following:

- for legal persons, Your production unit number (P number),
- · for individuals, Your CPR number and Your NemID.

If the Registry fails to validate Your information within 1 month following Your registration request, the Registry will delete Your domain name without indemnity nor refund and it will become available for registration under the "first-come first-served" basis.

### Verification procedure for contacts outside Denmark

The Registry carries out the validation process by sending You a letter to the address You have provided during Your registration request. If the letter is returned to the Registry due to incorrect contact details, the Registry will suspend Your domain name and eventually delete the domain name.

# Domain name activation

After You have made Your registration request on Our interface and the Registry has validated Your information for the contacts located in Denmark, the Registry sends You an email that allows You to activate Your domain name. To do this, please <u>log</u> You on the Registry website (with Your user ID and Your password indicated in the Registry's email) and follow the steps (the full procedure is available in Danish only),

Once You have activated Your domain name, the Registry sends You a confirmation email.

If Your domain name is not activated within the deadline given, it will be deleted by the Registry without indemnity nor refund and it will become available for registration under the "first-come first-served" basis.

# **Billing contact**

You expressly agree, by this contract, that, at the Registry, Gandi is assigned to the billing contact of Your domain name at the registration and throughout its registration with Gandi.

At any time, You can request to become the billing contact at the Registry or choose an other billing contact, by contacting Our customer service department. If You change the billing contact, Gandi will be not able to manage Your domain name and Your

domain name will be released to the Registry. Then You will have to manage Your domain name directly with the Registry.

#### Modification of the contact details

Updating the contact information associated to a .DK domain name via Your Gandi interface is not automatically reflected to the .DK Registry and can not be done by Gandi. In accordance with the .DK rules, to be effective with the Registry, the update must be made by You via the Registry interface. Refund

In any case, You will not be entitled to receive any refund if Your domain name is deleted by the Registry.

# Section .DK.4. Registration term

The registration term is 1 year, to avoid any deletion of the domain name, the renewal must be paid and funds cleared at least 26 days before the Expiration date.

## Section .DK.6. Storage of contact information

You accept that the .DK Registry can access Your personal contact information and display it in the public Whois database.

Individuals (natural persons) can opt-out of disclosing some personal information from the Registry Whois public database on request to the Registry and under some conditions which may be viewed at the following page:

Individuals having name and address protection in the Danish Civil Registration Register may be anonymous in the Registry Whois database.

The .DK Registry is obliged to deposit personal contact information collected at a designated repository institution for an unspecified period. As a main rule, the Registry deletes all personal contact information associated to a domain name in its databases at the latest 5 years after the deletion of the domain name.

## Section .DK.7. Dispute resolution policy

The .DK Registry has set forth a .DK domain name Alternative Dispute Resolution Policy (« Complaint Board ») that You agree fully abide by:

# Section .DK.8. Transfer (change of Registrar)

The process is started on Our Interface. Then, please contact Our customer service department to finalize Your transfer request (special procedure).

Before requesting the transfer of the domain, please be sure that Your domain name will **not expire in less than 1 month.** 

According to the Registry's technical rules, it is not possible to set a Transfer prohibited status on a .DK domain name, to avoid any transfer request.

The transfer of a .DK domain name does not change the domain's Expiration date.

# Section .DK.9. Ownership change

The change owner is launched from the Registry's website. Please fill out the change owner <u>form</u> on line, print and sign it, then send it to the Registry by standard mail, fax or email. Then, please contact Our customer service department to finalize the owner change.

The owner change of a .DK domain name does not change the domain's Expiration date.

## Section .DK.10. Deletion process

25 days before the Expiration date, the domain name is released by Gandi to the Registry. All the associated technical services are deactivated. The domain can not be renewed nor restored, it will be deleted by the Registry, and will become available for registration under the "first-come first-served" basis.

### Section .DK.11. Right of cancellation

In accordance with the Danish Consumer Contracts Act (forbrugeraftaleloven), when ordering a .DK domain name, You at the same time give Your consent to waive Your right of cancellation.
