



In addition to Gandi's [General Terms and Conditions](#) of domain name registration, the registration and use of a .IM domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

Section .IM.1. Trustee authority and Registry

.IM is the official country code Top-Level-Domain (ccTLD) of the Isle of Man. The following diagram presents the various parties involved and the Trustee Authority for the .IM TLD:



You can view the information and special rules of each party involved by clicking on the respective links.

Section .IM.2. Registration terms and conditions

When You apply to register a .IM domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .IM domain names, as defined by the Registry Domicilium, and which may be viewed on:

These contracts bind You to the .IM Registry. The present special conditions are not substitutes to these Rules, but are a part of it. You acknowledge to have fully understood and accepted these Rules on Our Website.

Section .IM.3. Special requirements

Second level .IM domain names are open to anyone worldwide. .IM special requirements are available on:

As exception to Our General Terms and Conditions of Domain Name Registration, .IM registration initial registration term is 1 up to 2 years.

Each registration period ends the date of Expiration, thus to avoid any deactivation of the domain name, the renewal must be paid and done **at least the day before the Expiration** date.

Some words are not available for .IM domains names registration:

- "Reserved Domains": pre-registered second level domains (like secondlevel.im) corresponding to third level domains (like thirdlevel.secondlevel.im) that have been issued in the past and that remain valid,
- words included on the .IM Black List (this list is not public), undesirable words, and words which are connected to regulated activities on the Isle of Man. Applicants for a domain name that is rejected for these reasons may appeal within 10 days of the rejection notice, stating the reasons why the name should be approved, by selecting the Appeal process available on the .IM Registry website.

Moreover, please note that:

- the Registry reserves the right to refuse the registration of domain names and revoke domain names at the request of the Designated Official (Isle of Man Government Officer)
- registration of one domain name does not entitle You to any rights to register or other rights over any similar domain name,
- the Registry reserves the right to check Your application for compliance with the Rules either before or after Your domain name is registered or renewed,
- in some instances the Registry may request certain information from You regarding Your legal identity when You make an application for or seek to amend the registration of a domain name.

Section .IM.5. Storage and use of personal data

You accept that Domicilium can access to Your personal data and display them in a public [whois](#) database.

Section .IM.6. Dispute resolution policy

Domicilium has set forth a specific .IM domain name Dispute Resolution Policy (IMDRP), that You agree fully abide by: <https://www.nic.im/public/disputeresolution.mth>

Section .IM.7. Transfer

Before requesting the transfer of the domain, please be sure that Your domain name:

- does not expire soon (We recommend that You start the transfer request at least one month before the domain's expiration)
- was created at least 60 days prior to the request, or renewed/transferred at least 7 days prior to the request.

The transfer to Gandi does not include any renewal. The creation date is reset at the Registry, and any remaining period is lost.

Section .IM.8. Ownership change

Besides Gandi's usual ownership change process, according to the [.IM Rules](#), the following process must be followed:

- a request is made to the current registrant of the Domain to "Unlock" the domain via email
- the current Registrant amends the domain record by logging on the www.nic.im website to "Unlock" from "Lock"
- a request is then made by the person requesting ownership for the domain to be transferred, through the www.nic.im website, which is automatically notified to the existing registrant
- the existing registrant approves or rejects the transfer request.

Section .IM.9. Deletion process

The renewal is possible until the day before Expiration.

The day before Expiration, the domain name is deleted, and becomes available for registration under the "first-come first-served" basis.
