

## ANNEX .MN - SPECIAL CONDITIONS FOR THE .MN ccTLD



In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .MN domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

### **Section .MN.1. Trustee authority and Registry**

.MN is the official country code Top-Level-Domain (ccTLD) of Mongolia. The following diagram presents the various parties involved and the Trustee Authority for the .MN ccTLD:

### **Section .MN.2. Registration terms and conditions**

When You apply to register a .MN domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .MN domain names, as defined by Datacom and Afilias, and which may be viewed at the following pages:

### **Section .MN.3. Special requirements**

.MN special requirements are available on:

.MN domain names are open to anyone.

To register for a .MN domain name, You must abide by the following conditions:

- the registration term is 1 up to 10 years,
- to avoid any deactivation of the domain name, the renewal must be paid and funds cleared **before the Expiration date**,
- provide and maintain accurate, reliable and up-to-date personal contact information, failing this the .MN Registry can delete Your domain name,
- names containing two characters followed by two hyphens are not allowed.

### **Section .MN.5. Storage of contact information**

You accept that .MN Registry and Afilias can access to Your personal data and display them in a public [Whois](#) database.

## **Section .MN.6. Dispute resolution policy**

The Registry has adopted ICANN's UDRP procedure and CoCCA's CRS procedure for the resolution of disputes for .MN domains, that You agree fully abide:

## **Section .MN.7. Transfer (change of Registrar)**

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend to start the transfer request at least one month before Expiration),
- was created and transferred at least 60 days prior to the request,
- if You just renewed Your domain name, We recommend that You not transfer it within the 45 days of its previous Expiration date (otherwise the Registry will not add 1 year to Your domain name, and You will lose out on the Renewal fees paid to the previous Registrar).

The transfer's completion requires your confirmation (by e-mail).

Upon successfully transferring a domain, the registration period is extended by one year.

## **Section .MN.8. Ownership change**

Owner changes are **not available on Our Website**. If You need to change the ownership of a domain name, please contact Our customer service department. The procedure consists in sending a [fax](#) to the Registry that has been signed by the 2 parties.

Upon successfully completing the owner change process, the registration period is extended by one year.

## **Section .MN.9. Deletion process**

**Upon the Expiration of the domain**, We suspend (Hold) the domain name for 30 days, during which time all the associated technical services are deactivated. The late renewal at normal prices is possible during this period.

Then, the domain name is placed on Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 30 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name, which will become available for registration under the "first-come first-served" basis.

## **Section .MN.10. Customer guarantee**

In any case, You commit Yourself to indemnify, defend and hold harmless the .MN Registry and Afilias and their directors, officers, shareholders, employees, agents and related companies from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable legal fees and expenses) arising out of or related to Your domain name registration or to its use. This guarantee shall prevail after the end of the present contract, whatever may be the cause, and is the direct consequence of our accreditation agreements with the .MN Registry and Afilias.
