

## ANNEX .SE - SPECIAL CONDITIONS FOR THE .SE ccTLD



In addition to Gandi's [General Terms and Conditions](#) of domain name registration, the registration and use of a .SE domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

### Section .SE.1. Trustee authority and Registry

.SE is the official country code Top-Level-Domain (ccTLD) of Sweden. The following diagram presents the various parties involved and the Trustee Authority for the .SE TLD:

### Section .SE.2. Registration terms and conditions

When You apply to register a .SE domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .SE domain names, as defined by IIS, and which may be viewed at the following pages:

### Section .SE.3. Special requirements

.SE special requirements are available at:

.SE domain names are open to anyone.

To register a .SE domain name, You must agree to the following conditions:

- the registration term is from 1 to 10 years,
- to avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 2 days before the Expiration date**,
- if You are located in Sweden, provide Us with a valid Swedish personal or organizational number (6 digits, dash, 4 digits),
- if You are located outside of Sweden, provide Us with Your ID number (Civic registration number, company registration number, or the equivalent),
- if You are a company located inside the European Union but outside Sweden, provide Us with Your VAT ID,
- provide and maintain accurate, reliable and up-to-date personal contact information, failing the .SE Registry can delete Your domain name,
- specify nameservers (DNS) that are correctly configured for the domain name that You intend to register, according to the Registry's "[zonecheck](#)" standards,
- some words are reserved or prohibited:

- names containing two characters followed by two hyphens are not allowed.

### Section .SE.4. Storage of contact information

You accept that the .SE Registry can access Your personal contact information and display it in the public [Whois](#) database.

By default, personal information of individuals (natural persons) is not published in the Whois database.

### **Section .SE.7. Transfer (change of Registrar)**

Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar, or by the [Registry IIS](#)), and that Your domain name does not expire soon.

The transfer of a .SE domain name does not change the domain's Expiration date.

### **Section .SE.8. Ownership change**

To change the owner of a domain name, please fill out the owner change [form](#), and send it by fax to Gandi with proofs of identity required.

The owner change of a .SE domain name does not change the domain's Expiration date.

### **Section .SE.9. Deletion process**

**1 day before the Expiration date**, the domain name is released by Gandi to the Registry. All associated technical services are deactivated.

At this time, the domain name is placed on Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 60 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name, which will become available for registration under the "first-come first-served" basis.
