

ANNEX .SI - SPECIAL CONDITIONS FOR THE .SI TLD

version 2.0 – January the 10th, 2025

In addition to Gandi's Corporate Special Conditions and General Terms and Conditions for domain name registration, the registration and use of a domain name in .SI imply the acceptance of and compliance to the present special conditions contained herein.

All legal information and contracts are presented to You at the time of the subscription to Our Services. Capitalized terms have the definition attributed to them in Our General Terms and Conditions of domain name registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

Section .SI.1. Naming organization

.SI is a generic Top-Level-Domain (gTLD).

Section .SI.2. Registration policies

When You apply to register a .SI domain name, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .SI domain names, as defined by ARNES, and which may be viewed at the following page:

.SI domain names are open to anyone.

You agree to provide and maintain accurate, reliable and up-to-date personal contact information. Failing to do so, the Registry may suspend and/or delete Your domain name.

You must specify nameservers (DNS) that are correctly configured for the domain name that You intend to register.

Section .SI.4. Registration term

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and funds cleared before the Expiration date.

Section .SI.6. Personal data

You consent to the collect, use, copying, distribution, publication, in particular in the Registry public [Whois](#) database if applicable, modification and other processing of Your personal data by the Registry, its technical provider and Our service provider, and their designees and agents for the purposes of providing domain name registration services and in accordance with the Registry privacy policy.

Section .SI.7. Dispute resolution policy

The Registry has adopted an alternative domain name dispute resolution procedure for .SI domain names, that You agree fully abide by:

Section .SI.8. Transfer (change of Registrar)

The transfer-in process may be initiated on Our Interface. Before requesting the transfer of the domain name, please make sure You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration).

Upon successfully transferring a domain name, the registration period remains unchanged

Section .SI.9. Ownership change

The owner change process requires Gandi owner change form with supporting document.

The owner change of a domain name does not change the Expiration date.

Section .SI.10. Deletion process

Upon the Expiration, the domain name goes into Redemption Period for 30 days. It can only be restored case by case by contacting our support team.

If the domain name is neither renewed nor restored within these deadlines, it will become available for registration on a "first-come first-served" basis.
