

In addition to Gandi's <u>General Terms and Conditions</u> for domain name registration, the registration and use of a .IE domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in Our <u>General Terms and Conditions</u> of domain name registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

Section .IE.1. Trustee authority and Registry

.IE is the official country code Top-Level-Domain (ccTLD) of Ireland. The following diagram presents the various parties involved and the naming organization for the .IE TLD:



You can view the information and special rules of each party involved by clicking on the respective links.

Section .IE.2. Registration terms and conditions

When You apply to register a .IE domain name, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .IE domain names, as defined by IEDR and which may be viewed at the following page:

These policies, that You acknowledge to have fully understood and to have accepted via Our website bind You to the .IE Registry. The present special conditions do not replace these rules, which are incorporated by reference, and are binding on Gandi and You.

Section .IE.3. Special requirements

Eligibility conditions

.IE domain names are open to persons having a real and substantive connection with Ireland as specify in Registration and Naming Policy:

Registration and Naming Policy Statement) In addition the owner and administrative contacts must be identical (same Gandi handle). In case of the contact is a legal person, the person indicated into the contact must be a member or an employee of Your entity having the authorization to act for the account of Your entity in the framework of the management of Your .ie domain name. Indeed at the Registry level the physical person declared into the administrative contact has the capacity to perform any modification on the domain name.

You must provide and maintain accurate, reliable and up-to-date personal contact information, failing this the Registry can delete Your domain name.

Registration procedure

During Your registration request on Our interface, You have to indicate the following information:

- Your registrant type,
- any information supporting Your eligibility, as for example Your company business number or Your trademark number.

Once Your request has been made on Our website, additional documentary evidence (official or certified copies) may be required by the Registry in order to prove Your link with Ireland.

If documentary evidence is required by the Registry, Gandi will contact You by email. These documents have to be provided to the Registry within 27 days following Your registration request.

In addition, You shall specify at least 2 nameservers (DNS) that are correctly configured for the domain name that You intend to register. If the DNS are not correctly configured within a deadline of 20 days following Your registration request, Your registration request will be rejected by the Registry.

When You make Your registration request You accept the conditions of liability and indemnity as established in the Registry policies and agree to submit to the dispute resolution policy as established by the Registry.

Section .IE.4. Registration term

The registration term is from 1 to 10 years. To avoid any deactivation of the domain name, the renewal must be paid and funds cleared **before the Expiration date**.

Section .IE.6. Storage of contact information

You consent to the use, copying, distribution, publication, in particular in the Registry public <u>Whois</u> database if applicable, modification and other processing of Your personal data by the Registry, its technical provider and their designees and agents for the purposes of providing Registry services and in accordance with the Registry privacy policy.

Section .IE.7. Dispute resolution policy

The Registry has adopted alternative dispute resolution policies

for .IE, that You agree fully abide by:

The dispute resolution policies established by the Registry shall not prevent the submission of the dispute to a court of law for independent resolution at any time.

Section .IE.8. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the transfer of the domain name, please be sure that You have the domain name authorization code (supplied by Your current Registrar).

The transfer of a .IE domain name does not change the domain name expiration date.

Section .IE.9. Ownership change

If You need to make an owner change, please contact Our customer service department. The procedure is subject to the rules and conditions established in article 19. "Sale of Rights to use Domain Names" of Registrant Terms and Conditions in appendix and is subject to the payment of the corresponding fees, except specific cases (ie: acquisition/merge of the registrant's company or where the owner is an individual who has passed away).

The owner change of a .IE domain name does not change the domain name expiration date.

Section .IE.10. Deletion process

Upon the expiration of the domain name, We suspend (Hold) the domain name for 69 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

If the domain name is not renewed within the given deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
