

ANNEX .LV - SPECIAL CONDITIONS FOR THE .LV ccTLD



In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .LV domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of domain name registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

Section .LV.1. Trustee authority and Registry

.LV is the official country code Top-Level-Domain (ccTLD) of Latvia. The following diagram presents the various parties involved and the naming organization for the .LV TLD:



You can view the information and special rules of each party involved by clicking on the respective links.

Section .LV.2. Registration terms and conditions

When You apply to register a .LV domain name, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .LV domain names, as defined by NIC, and which may be viewed at the following page: <https://www.nic.lv/en/policies>

These policies, that You acknowledge to have fully understood and accepted via Our website, are binding between You and the .LV Registry. The present special conditions do not replace these rules, which are incorporated by reference, and are imposed to Gandi and You.

Section .LV.3. Special requirements

.LV special requirements are available at: <http://www.gandi.net/domain/lv/info>

.LV domain names are open to anyone.

During the registration of a .LV domain name:

- for legal persons, indicate Your company registration number,
- for Latvian residents, indicate Your person code,
- if You are an individual, indicate Yourself as administrative contact,
- if You are a legal person, the administrative contact must be an individual.

You agree to provide and maintain accurate, reliable and up-to-date

personal contact information, failing that the .LV Registry may suspend and/or delete Your domain name.

Section .LV.4. Registration term

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and funds cleared no later than 2 days before the Expiration date.

Section .LV.6. Storage of contact information

You consent to the use, copying, distribution, publication, in particular in the Registry public [Whois](#) database if applicable, modification and other processing of Your personal data by the Registry, its designees and agents for the purpose of providing Registry services and in accordance with the Registry privacy policy.

Section .LV.7. Dispute resolution policy

The Registry haven't established any particular dispute resolution policy concerning .LV domain names.

Section .LV.8. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the transfer of the domain name, please be sure that You have the domain name authorization code (supplied by Your current Registrar), and that Your domain name:

- will not expire in less than 35 days,
- was created at least 60 days prior to the request.

The transfer does not change the domain name Expiration date.

Section .LV.9. Ownership change

The ownership change requires the provision of Gandi ownership change form with the required proofs of identity.

The owner change does not modify the domain name Expiration date.

Section .LV.10. Deletion process

2 days before the Expiration date, the domain name is released by Gandi to the Registry. All associated technical services are deactivated.

At this time, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 30 calendar days.

If the domain name is neither renewed nor restored within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
