In addition to Gandi's <u>Domain name registration contract</u>, the registration and use of a .NU domain name implies the acceptance of and compliance to the present special conditions contained herein.

All legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in Our <u>Domain name registration contract</u>. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

.NU domain names are open to anyone.

During the registration process, You have to provide the following:

- if You are an individual, Your ID number (passport number ...),
- if You are a legal person, Your registration number (corporate/business number...).
- in addition, if You are a legal person located inside the European Union but outside Sweden, Your VAT number (if applicable).

You agree to provide and maintain accurate, reliable and up-to-date personal contact information. Failing to do so, the Registry may suspend and/or delete Your domain name.

As part of the registration of Your domain name, the Registry may require to Gandi to process to the verification of Your identity and contact details associated to Your domain name. In that case Your domain name is registered but remains inactive (serverHold) and locked againts renewal and transfer to an other registrar during the verification process. Gandi will request You to provide an identity document or company registration certificate and proof of address. Your domain name will be activated by the Registry after Your information will be confirmed and verified by Gandi. The Registry may also request Gandi to send it Your supporting documents.

Section .SE.4. Registration term

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and funds cleared no later than 2 days before the Expiration date.

The transfer does not change the domain name Expiration date.

Section .NU.9. Ownership change

To change the owner of a domain name, please fill out the owner change form, and send it to Gandi with proofs of identity.

The owner change does not change the domain name Expiration date.

Section .NU.10. Deletion process

1 day before the Expiration date, Gandi removes the domain name. All associated technical services are deactivated.

At this time, the domain name goes into Redemption Period for 60 days. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

If the domain name is neither renewed nor restored within these deadlines, the Registry shall place the domain name in "Pending Delete" status for several days, and then delete the domain name, which will become available for registration on a "first-come first-served" basis.
