

## ANNEX .SE - SPECIAL CONDITIONS FOR THE .SE ccTLD

version 1.5 – December 24, 2024

In addition to Gandi's [Domain name registration contract](#), the registration and use of a .SE domain name implies the acceptance of and compliance to the present special conditions contained herein.

All legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [Domain name registration contract](#). Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

### Section .SE.1. Naming organization

.SE is the official country code Top-Level-Domain (ccTLD) of Sweden.

### Section .SE.2. Registration policies

When You apply to register a .SE domain name, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .SE domain names, as defined by The Swedish Internet Foundation and which may be viewed at the following page:

These policies, that You acknowledge to have fully understood and to have accepted via Our website bind You to the .SE Registry. The present special conditions do not replace these rules, which are incorporated by reference, and are binding on Gandi and You.

### Section .SE.3. Special requirements

.SE special requirements are available at:

.SE domain names are open to anyone.

During the registration process, You have to provide the following:

- if You are located in Sweden, Your Swedish personal or organizational number (6 digits, dash, 4 digits),
- if You are located outside of Sweden, Your ID number or organization registration number,
- if You are a company located inside the European Union but outside Sweden, Your VAT ID.

You agree to provide and maintain accurate, reliable and up-to-date personal contact information. Failing to do so, the Registry may suspend and/or delete Your domain name.

As part of the registration of Your domain name, the Registry may require to Gandi to process to the verification of Your identity and contact details associated to Your domain name. In that case Your domain name is registered but remains inactive (serverHold) and locked against renewal and transfer to an other registrar during the verification process. Gandi will request You to provide an identity document or company registration certificate and proof of address. Your domain name will be activated by the Registry after Your information will be confirmed and verified by Gandi. The Registry may also request Gandi to send it Your supporting documents.

You have to specify nameservers (DNS) that are correctly configured for the domain name that You intend to register, according to the Registry's "[zonecheck](#)" standards.

### Section .SE.4. Registration term

The registration term is 1 year. To avoid any deletion of the domain name, the renewal must be paid and funds cleared no later than 2 days before the Expiration date.

### Section .SE.6. Personal data

You consent to the collect, use, copying, distribution, publication, in particular in the Registry public [Whois](#) database if applicable, modification and other processing of Your personal data by the Registry, its technical provider and their designees and agents for the purposes of providing domain name registration services and in accordance with the Registry privacy policy.

### Section .SE.7. Dispute resolution policy

The Registry has adopted an Alternative Dispute Resolution (ADR) for .SE domain names, that You agree fully abide by:

### Section .SE.8. Transfer (change of Registrar)

The transfer-in process may be initiated on Our Interface. Before requesting the transfer of the domain name, please make sure You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name does not expire soon.

The transfer does not change the domain name's Expiration date.

### Section .SE.9. Ownership change

To change the owner of a domain name, please fill out the owner change form, and send it to Gandi with proofs of identity.

The owner change does not change the domain name's Expiration date.

### Section .SE.10. Deletion process

1 day before the Expiration date, Gandi removes the domain name. All associated technical services are deactivated.

At this time, the domain name goes into Redemption Period for 60 days. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

If the domain name is neither renewed nor restored within these deadlines, the Registry shall place the domain name in "Pending Delete" status for several days, and then delete the domain name, which will become available for registration on a "first-come first-served" basis.
