

In addition to Gandi's <u>General Terms and Conditions</u> for domain name registration, the registration and use of a .MU domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our <u>website</u>. Capitalized terms have the definition attributed to them in Our <u>General Terms and Conditions</u> of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

## Section .MU.1. Trustee authority and Registry

.MU is the official country code Top-Level-Domain (ccTLD) of Republic of Mauritius. The following diagram presents the various parties involved and the Trustee Authority for the .MU TLD:

### Section .MU.2. Registration terms and conditions

## Section .MU.3. Special requirements

.MU domain names are open to anyone.

You must provide and maintain accurate, reliable and up-to-date personal contact information, failing the .MU Registry and CoCCA can delete Your domain name.

## Section .MU.4. Registration terms

The registration term is from 1 to 10 years. To avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 2 days before the Expiration date**.

# Section .MU.8. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- · does not have a TransferProhibited status,
- does not expire soon (We recommend to start the transfer request at least one month before Expiration),
- was created and renewed at least 15 days prior to the request.

The transfer's completion requires your confirmation (by e-mail).

Upon successfully transferring a domain, the registration period is extended by one year.

# Section .MU.9. Ownership change

The ownership change process is available on Our Interface, it requires the confirmation of the two parties by e-mail.

The owner change of a .MU domain name does not change the domain's Expiration date.

# Section .MU.10. Deletion process

1 day before the Expiration date, the domain name is released by Gandi to the Registry. All associated technical services are deactivated.

At this time, the domain name is placed on Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period

If the domain is neither renewed nor restored within these deadlines, the Registry will delete the domain name and it will become available to registration at the Registry's discretion.
