

ANNEX .FI - SPECIAL CONDITIONS FOR THE .FI ccTLD

version 2.1 – June the 9th, 2020

In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .FI domain name implies the acceptance of and compliance to the present special conditions contained herein.

All legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of domain name registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

Section .FI.1. Naming organization

.FI is the official country code Top-Level-Domain (ccTLD) of Finland.

The parties involved in naming organization for .FI are:

Section .FI.2. Registration policies

When You apply to register a .FI domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .FI domain names, as defined by the Registry, and which may be viewed at the following page:

These policies, that You acknowledge to have fully understood and to have accepted via Our website bind You to the .FI Registry. The present special conditions do not replace these rules, which are incorporated by reference, and are binding on Gandi and You.

Section .FI.3. Special requirements

Eligibility conditions

.FI domain names are open to anyone:

During the registration of Your domain name, please indicate:

- Your "type": individual, company, association, foundation, political party, municipality, government, community.
- If You are a Finnish person.
- For Finnish individuals: Your Finish identity number, for other individuals: Your birth date.
- For legal person: Your registration number.

Technical conditions

If You specify nameservers (DNS) they must be correctly configured for the domain name that You intend to register, according to the Registry "[zonecheck](#)" standards.

Section .FI.4. Registration term

The registration term is 1 to 5 years. To avoid any deactivation of the domain name, the renewal must be paid and funds cleared before the Expiration date.

Section .FI.6. Personal data

You consent to the use, copying, distribution, publication, in particular in the Registry public [Whois](#) database if applicable, modification and other processing of Your personal data by the Registry for the purposes of providing Registry services and in accordance with the Registry privacy policy.

Section .FI.7. Dispute resolution policy

The .FI Registry has established a .FI domain name alternative dispute resolution policy that You agree fully abide by:

Section .FI.8. Transfer (change of Registrar)

The process is started on Our Interface. Before requesting the transfer of the domain name, please be sure that:

- You have the domain name's authorization code (supplied by Your current Registrar),
- Your domain name does not expire soon (We recommend that you start the transfer request at least one month prior to its Expiration).

The transfer's completion requires Your confirmation (by e-mail).

The transfer of a .FI domain name does not change the domain name's Expiration date.

In accordance with the .FI Registry technical specifications, it is not possible to set a Transfer Prohibited status on a .FI domain name in order to avoid transfers.

Section .FI.9. Ownership change

The owner change is available via Our Interface. After validation of the 2 parties by email, the current owner will receive an email from the Registry with a code that must be provided to Gandi in order to finalize the process.

The owner change of a .FI domain name does not change the domain name's Expiration date.

Section .FI.10. Deletion process

Upon the Expiration, the domain name is suspended for 30 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

If the domain name is not renewed within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.

Section .FI.11. Verification of holder information

To verify the reachability of the owner, Gandi sends an email to the email address associated to the domain name owner contact. Failing to validate this email within 15 days, the owner account and the .FI domain names associated will be suspended.

In addition, once a year, Gandi sends an email to the owner account email address requesting to verify the accuracy of the information associated to its domain name, and to update it if necessary.
