

## ANNEX .GG/.JE - SPECIAL CONDITIONS FOR THE .GG and .JE ccTLDs

version 1.3 – June 24th, 2020

In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .GG or a .JE domain name implies the acceptance of and compliance to the present special conditions contained herein.

All legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of domain name registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

### **Section .GG/.JE.1. Naming organization**

.GG is the official country code Top-Level-Domain (ccTLD) of Guernsey and .JE the official ccTLD of Jersey.

### **Section .GG/.JE.2. Registration policies**

When You apply to register a .GG or a .JE domain name, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .GG and .JE domain names, as defined by Island Networks Ltd, and which may be viewed at the following pages:

.GG and .JE domain names are open to anyone.

Some words are prohibited or reserved, or subject to special conditions or procedures: [5. Reserved Words and String Patterns](#).

You have to provide and maintain accurate, reliable and up-to-date personal contact information, failing this the Registry may delete Your domain name.

Privacy and proxy services are not allowed by the Registry.

### **Section .GG/.JE.4. Registration term**

The registration term is from 1 to 2 years. To avoid any deactivation of the domain name, the renewal must be paid and funds cleared before the Expiration date.

### **Section .GG/.JE.6. Personal data**

You consent to the use, copying, distribution, publication, in particular in the Registry public [Whois](#) database if applicable, modification and other processing of Your personal data by the Registry for the purposes of providing domain name registration services and in accordance with Registry privacy policy.

### **Section .GG/.JE.7. Dispute resolution policy**

The Registry has established a dispute resolution service (DRS) for .GG and .JE domain names that You agree fully abide by:

### **Section .GG/.JE.8. Transfer (change of Registrar)**

The process is started on Our Interface. Before requesting the transfer of the domain name, please be sure that You have the domain name authorization code supplied by Your current Registrar (if no auth code is supplied the transfer has to be approved by the losing Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend that you start the transfer request at least one month prior to its Expiration).

The transfer's completion requires Your confirmation (by e-mail).

Upon successfully transferring a domain name, the registration period is extended by one year.

### **Section .GG/.JE.9. Ownership change**

The ownership change process is available on Our Interface, it requires the confirmation of the two parties by e-mail.

The owner change of a .GG or a .JE domain name does not change the domain name Expiration date.

### **Section .GG/.JE.10. Deletion process**

**Upon the Expiration**, the domain name is suspended for 30 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain name goes into Redemption Period for an additional 5 days. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

After these periods the domain name may still be restored manually at the Registry level for an approximately additional 10 days period, please contact Our customer department. An additional fee will be requested by the Registry.

**If the domain name is neither renewed nor restored within these deadlines, either the Registry will delete the domain**

name, which will become available for registration on a “first come first served” basis, or the domain name will be retained | by the Registry and may become available on auction at the Registry entire and sole discretion.
