

## ANNEX .GR - SPECIAL CONDITIONS FOR THE .GR and .ελ ccTLDs

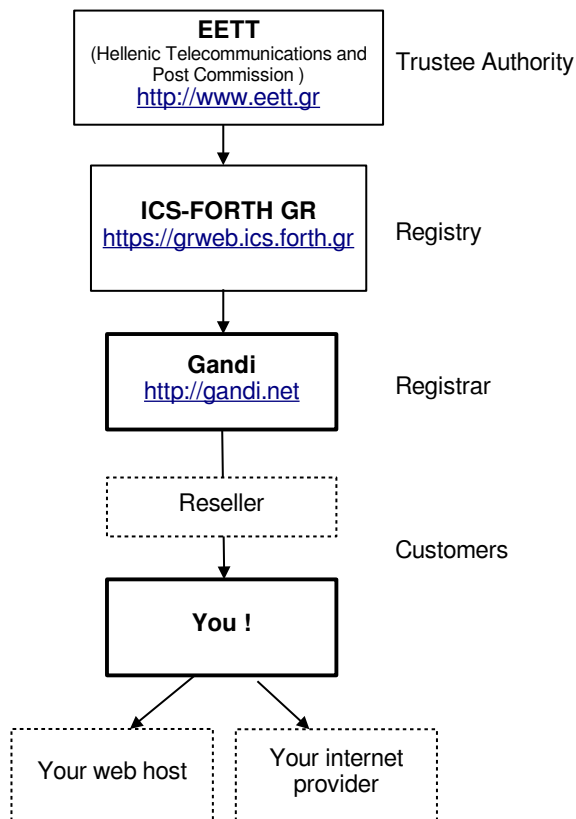

In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .GR ou .ελ domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, “You” refers to the owner of the domain name, and “We” designates Gandi.

### Section .GR.1. Trustee authority and Registry

.GR and .ελ (.xn--qxam, that corresponds to .GR in Greek language) are the official country code Top-Level-Domains (ccTLDs) of Greece. The following diagram presents the various parties involved and the Trustee Authority for the .GR and .ελ TLDs:



You can view the information and special rules of each party involved by clicking on the respective links.

### Section .GR.2. Registration terms and conditions

When You apply to register a .GR or .ελ domain name, You acknowledge that You have fully understood and full knowledge of and You agree to abide by all the rules and specific conditions of .GR and .ελ domain names, as defined by EETT and ICS-FORTH GR, and which may be viewed at the following page:

These contracts bind You to the .GR Trustee Authority and Registry. The special conditions contained herein do not replace these rules, but rather form part of them. You acknowledge to have fully understood and accepted these rules on Our website.

### Section .GR.3. Special requirements

.GR and .ελ domain names are open to anyone.

.COM.GR domain names are reserved to persons engaging in commercial activities, .ORG.GR to non-profit organizations, .NET.GR to Internet service providers, and .EDU.GR to educational organizations.

Gandi does not provide reserved geographical names and .GOV.GR (reserved to governmental organizations).

Gandi does not manage the “bundles”, in consequence it is not possible to activate a reserved domain name or to transfer to Gandi a main domain name include in a “bundle” for which You have activated domain names.

Gandi commits to submit any registration requests of a .GR or .ελ domain name to the Registry automatically on receipt of all the information required and on validation of the full payment. Once the registration request submitted to the Registry, the Registry will assign a reference number to Your request.

The time of priority of registration requests is only ensure upon the assignment of a reference number for Your request by the Registry and not upon the submission of Your registration request on Our website.

Once Your registration request submitting to the Registry, the domain name will be temporally assigned to You and activate for a period of 6 days, during which the Registry will verify the compliance of Your request with the rules applicable to the .GR and .ελ. Once Your domain name registered, the Registry informs You by email.

In any case You have to provide and maintain accurate, reliable and up-to-date personal contact information, failing this the Registry can delete Your domain name.

### Section .GR.4. Registration term

The registration term is 2 years. To avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 2 days before the Expiration date**.

### Section .GR.6. Storage of contact information

You consent to the collection, use and publication, in particular into the Registry [Whois](#) database if applicable, of Your personal data by ETT and the Registry.

### Section .GR.7. Dispute resolution policy

EETT has set forth a specific alternative dispute resolution policy for .GR and .ελ domain names that You agree fully abide by: <https://grweb.ics.forth.gr/public/domains/regulation?lang=en> (Regulation on Management and Assignment of .gr and .ελ – in particular Article 10 A) 2.)

### **Section .GR.8. Transfer (change of Registrar)**

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name does not expire soon (We recommend that you start the transfer request at least one month prior to its Expiration).

The transfer of a .GR or .ελ domain name does not change the domain's Expiration date.

Once the transfer made, the new authorization code associated to Your domain name is automatically provide by Gandi. You can modify this authorization code on request.

### **Section .GR.9. Ownership change**

Owner changes are **not available on Our website**. If You need to change the ownership of a domain name, please contact Our customer service department.

The owner change of a .GR or .ελ domain name does not change the domain's Expiration date.

### **Section .GR.10. Deletion process**

**1 day before the Expiration date**, the domain name is deleted by Gandi. All associated technical services are deactivated.

At this time, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 15 calendar days.

If the domain name is neither renewed nor restored within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.

### **Section .GR.11. Specific terms for .GR and .ελ domain names**

In accordance with EETT rules and pursuant to Law No. 1599/86, by submitting Your requests for registration, modification of Your contact details, owner change and transfer, You acknowledge that You making the following solemn statements.

#### **Registration**

By submitting a registration request on Our website, You are making a solemn statement that:

- all data declared are accurate and true,
- in the case of a legal person, the declaration shall be binding the specific legal person,
- to Your best of knowledge the registration of the domain name does not violate the rights of any third parties,
- in case the domain name is a [reserved geographical term](#) (not managed by Gandi), You are the corresponding local government organization entitled to register this domain name,

- for the registration of a .GOV.GR domain name (not managed by Gandi), You are a governmental organisation,
- for the registration of a third level domain name, You are eligible to the registration of a domain name under the sub-extension chosen in accordance with the Registry rules:

#### **Modification of Your contact details**

By making any modification of Your contact details on Our interface, You are making a solemn statement that:

- all data declared are accurate and true,
- in the case of a legal person, that the declaration shall be binding upon the specific legal person.

By requesting a change of name of the domain name holder (without owner change), You are making a solemn statement that:

- all data declared are accurate and true,
- in the case of a legal person, that the declaration shall be binding upon the specific legal person,
- despite Your change of name, the old and the new holder of the domain name are identical as proved by the relevant legalizing documents enclosed with Your request.

#### **Owner change**

By accepting an owner change request, the new holder is making a solemn statement that:

- all data declared are accurate and true,
- in the case of a legal person, that the declaration shall be binding upon the specific legal person,
- in case of a domain name registered under a sub-extension, You are eligible to the registration of a domain name under the sub-extension chosen in accordance with the Registry rules:

- in the case of owner change due to cession, merger, modification of legal form ..., the person requesting the owner change is the beneficiary legal person as proved by the relevant legalizing documents enclosed with Your request,
- in the case of owner change due to an universal succession, the person requesting the owner change is the legal successor as proved by the relevant legalizing documents enclosed with Your request.

#### **Transfer**

By submitting a transfer request to Gandi on Our website, You are making a solemn statement that:

- all data declared are accurate and true,
- You have fulfilled all Your financial obligations to Your previous Registrar pertaining to the domain name for which You request the transfer,
- in the case of a legal person, that the declaration shall be binding upon the specific legal person.
