

# ANNEX ICM Registry - SPECIAL CONDITIONS FOR THE TLDS .ADULT, .PORN, .SEX, .XXX

version 2.1 – October the 29<sup>th</sup>, 2019

In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .ADULT, .PORN, .SEX or .XXX domain name implies the acceptance of and compliance to the present special conditions contained herein.

Legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of domain name registration. Specifically, “You” refers to the owner of the domain name, and “We” designates Gandi.

## **Section .ICM.1. Naming organization**

.ADULT, .PORN, .SEX and .XXX are generic Top-Level-Domains (gTLDs) dedicated to websites for adults. The following diagram presents the various parties involved and the naming organization for these TLDS:

## **Section .ICM.2. Applicable policies**

When You apply to register a .ADULT, .PORN, .SEX or .XXX domain name, You acknowledge You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .ADULT domain names, as defined by ICANN and ICM Registry and which may be viewed at the following pages:

.ADULT, .PORN and .SEX domain names are open to anyone.

.XXX domain names are open to the members of the adult entertainment industry (“the sponsored community”).

However, the persons who are not member of the sponsored community can registered .XXX domain names, these domain names will be inactive (non-resolving domain names).

## **.XXX authentication process**

The members of the sponsored community will have to be authenticated as member of the sponsored community for activate their domain names.

If You are not yet authenticated, once Your application made on Our website, the Registry will send You an email to the email address associated to the owner contact (one unique email per email address) with a link to the authentication form.

Important: the email address associated to the owner contact must be the email address of the domain name owner.

You commit to comply with the [IFFOR rules](#) (the International Foundation For Online Responsibility in charge of .XXX policies). Thereby You must agree to permit automated scanning of any website associated or forwarding to Your domain name for vulnerabilities (phishing, malware ...) and for compliance with IFFOR policies, and You must agree not to employ technological or other means to defeat or prevent such scanning.

## **Section .ICM.4. Reserved names**

Some words are reserved or prohibited, in particular ICANN reserved names:

## **Section .ICM.5. Registration term**

The registration term is from 1 to 10 years. To avoid any deactivation of the domain name, the renewal must be paid and funds cleared before the Expiration date.

“Premium” domain names are subject to specific prices as displayed during Your order.

## **Section .ICM.7. Personal information**

In application of ICANN contracts, all personal and technical information associated with the registration of Your domain name is

recorded and made available to ICANN and IRON MOUNTAIN (ICANN's designated Registrar Data Escrow agent), in addition to messages pertaining to each registration or modification, during the entire duration of the registration of the domain name, plus the two following years.

You consent to the use, copying, distribution, publication, in particular in the Registry public [Whois](#) database if applicable, modification and other processing of Your personal data by the Registry, its technical provider and their designees and agents for the purposes of providing Registry services as defined in the Registry agreement with ICANN and in accordance with the Registry privacy policy.

### **Section .ICM.8. Dispute resolution policy**

The Registry has adopted the ICANN dispute resolution procedures UDRP (Uniform Dispute Resolution Policy) and URS (Uniform Rapid Suspension System) for .ADULT, .PORN, .SEX and .XXX domains, that You agree fully abide by.

### **Special procedures applicable to .XXX**

The following procedures are also applicable to .XXX domain names:

- CEDRP procedure (Charter Eligibility Dispute Resolution Policy) established by ICANN relative to the infringement of eligibility conditions.
- RES procedure (Rapid Evaluation Service) is a suspension process applicable for certain situations involving a clear abuse.

### **Section .ICM.9. Transfer (change of Registrar)**

The transfer-in process may be initiated on Our Interface. Before requesting the transfer of the domain, please make sure You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend that You start the transfer request at least 1 month prior to its Expiration),
- was created at least 60 days prior to the request,
- has not been transferred within the last 60 days.

The transfer's completion requires Your confirmation (by e-mail).

Upon successfully transferring a domain, the registration period is extended by one year.

### **Section .ICM.10. Ownership change**

The ownership change process is available on Our Interface and requires the confirmation of both parties by e-mail.

The owner change of a domain name does not change the domain's

expiration date.

### **Section .ICM.11. Deletion process**

**Upon the Expiration of the domain**, We suspend (Hold) the domain name for 45 days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

Then the domain goes into Redemption Period for an additional 30 days, and all associated technical services are deactivated. It can only be restored during this period in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department.

If the domain is neither renewed nor restored within these deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name, which will become available for registration on a "first-come first-served" basis.

### **Section .ICM.12. Registrant representations and guarantees**

You agree to provide and maintain accurate, reliable and up-to-date personal contact information. Failing to do so, the Registry may delete Your domain name.

In any case, You acknowledge and agree that distributing malware, abusively operating botnets, phishing, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise engaging in activity contrary to applicable law are expressly prohibited. Failing to comply with this provision, You expose Yourself to the suspension of Your domain name, in addition to the prosecution for the prejudice caused to third parties and to the penalties mentioned under applicable law.

You commit Yourself to indemnify, defend and hold harmless the Registry and its subcontractors, and the directors, officers, employees, affiliates and agents of each of them, from and against any and all claims, damages, liabilities, costs and expenses, including reasonable legal fees and expenses, arising out of or relating in any way to Your domain name. This indemnification obligation shall survive the termination of the present contract, whatever may be the cause, and is the direct consequence of Our accreditation agreement.

### **Section .ICM.13. Exclusion of liability and actions of the Registry**

You expressly acknowledge and accept that the Registry shall be entitled, that it deems necessary, in its sole and entire discretion, but not obligated, to reject, delete, transfer to a third party or place in "lock" status, "hold" status or similar status Your domain name or any transaction:

- to protect the integrity and stability of the domain names system,
- to comply with applicable laws, regulations, policies, government rules or requirements, request of law enforcement or in accordance with an order or decision by a competent court or administrative authority, or any dispute resolution service provider the Registry and ICANN may retain to oversee the arbitration and mediation of disputes,
- to avoid any civil or criminal liability on the part of the Registry, its affiliates, subsidiaries, officers, directors, employees and contractors,
- to correct mistakes made by the Registry or any Registrar in connection to the registration of a domain name,
- for violation of the Registry rules,
- for the non-payment of fees to the Registry.

The Registry also reserves the right to place Your domain name in « lock » status, « hold » status or similar status during resolution of a dispute.
