

## ANNEX .LV - SPECIAL CONDITIONS FOR THE .LV ccTLD

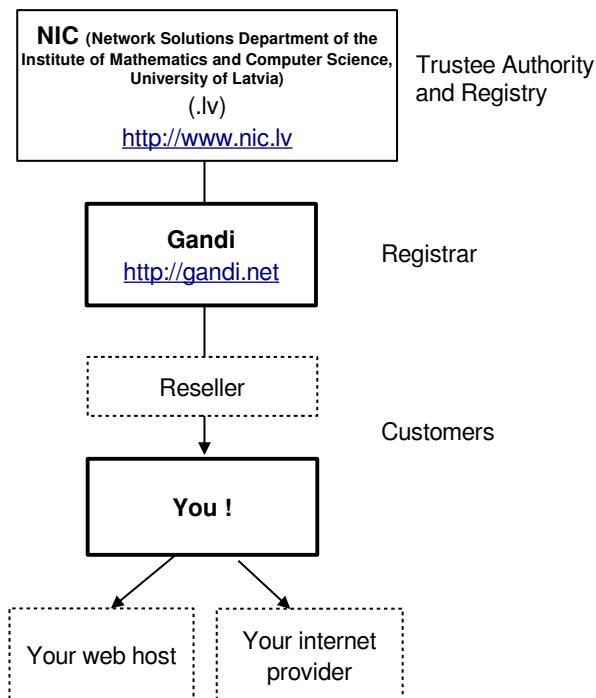

In addition to Gandi's [General Terms and Conditions](#) for domain name registration, the registration and use of a .LV domain name implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

### Section .LV.1. Trustee authority and Registry

.LV is the official country code Top-Level-Domain (ccTLD) of Latvia. The following diagram presents the various parties involved and the Trustee Authority for the .LV TLD:



You can view the information and special rules of each party involved by clicking on the respective links.

### Section .LV.2. Registration terms and conditions

When You apply to register a .LV domain name, You acknowledge that You have fully understood, and that You certify to have full knowledge of and that You agree to abide by all the rules and specific conditions of .LV domain names, as defined by NIC, and which may be viewed at the following page: <https://www.nic.lv/en/policies>

These contracts are binding between You and the .LV Registry. The special conditions contained herein do not replace these Rules, but rather form part of them. You acknowledge to have fully understood and accepted these rules on Our website.

### Section .LV.3. Special requirements

.LV special requirements are available at: <http://www.gandi.net/domain/lv/info>

.LV domain names are open to anyone.

To register a .LV domain name, You must agree to the following conditions:

- the registration term is 1 year,
- to avoid any deletion of the domain name, the renewal must be paid and funds cleared **no later than 2 days before the Expiration date**,
- for legal persons, indicate Your company registration number,
- for Latvian residents, indicate Your person code,
- provide and maintain accurate, reliable and up-to-date personal contact information, failing this the .LV Registry can delete Your domain name,
- some words are reserved or prohibited, in particular the name of individuals: <https://www.nic.lv/en/policy.html> (6.2),
- names containing two characters followed by two hyphens are not allowed.

Rules regarding the administrative contact:

- if You are an individual, You have to indicate Yourself as administrative contact,
- if You are a legal person, the administrative contact must be an individual.

### Section .LV.5. Storage of contact information

You accept that the .LV Registry can access Your personal contact information and display it in the public [Whois](#) database. (except the name of individuals).

### Section .LV.6. Dispute resolution policy

The Registry does not have any particular dispute resolution policy in place concerning .LV domain names. It is up to the parties involved in the dispute to resolve the dispute between themselves, either amicably or through the courts.

### **Section .LV.7. Transfer (change of Registrar)**

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- will **not expire in less than 35 days**,
- was created at least 60 days prior to the request.

The transfer's completion requires Your confirmation (by e-mail).

The transfer of a .LV domain name does not change the domain's Expiration date.

### **Section .LV.8. Ownership change**

The ownership change process is available on Our Interface and requires the confirmation of both parties (current and new owner) by e-mail.

The owner change of a .LV domain name does not change the domain's Expiration date.

### **Section .LV.9. Deletion process**

**2 days before the Expiration date**, the domain name is released by Gandi to the Registry. All associated technical services are deactivated.

At this time, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 30 calendar days.

If the domain is neither renewed nor restored within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
