

## ANNEX .RADIO.FM - SPECIAL CONDITIONS FOR THE .RADIO.FM SLD

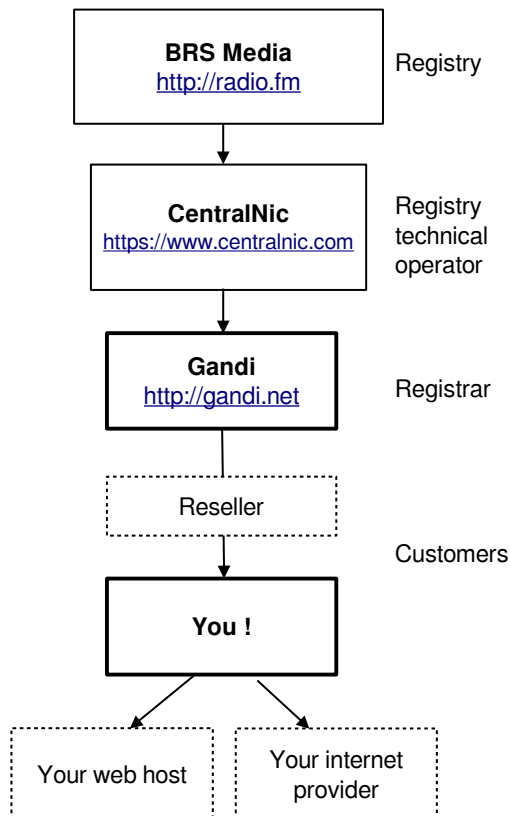

In addition to Gandi's [General Terms and Conditions](#) of domain name registration, the registration and use of a .RADIO.FM domain name implies the acceptance of and compliance to the present special conditions.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in Our [General Terms and Conditions](#) of Domain Name Registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi. Your current contracts are freely available for viewing when You log into Your account at: <http://www.gandi.net/admin/contracts/>.

### Section .RADIO.FM.1. Trustee authority and Registry

.RADIO.FM is a second level extension dedicated to media, music, audio and video sectors. The following diagram presents the various parties involved and the Trustee Authority for the .RADIO.FM ccTLD:

### Section .RADIO.FM.2. Registration terms and conditions

When You apply to register a .RADIO.FM domain name, You acknowledge to have fully understood, and You agree to have full knowledge of and to abide by all the rules and specific conditions of .RADIO.FM domain names, as defined by BRS Media and CentralNic, and which may be viewed at the following page:

### Section .RADIO.FM.3. Special requirements

.RADIO.FM domain names are open to anyone.

To register a .RADIO.FM domain name, You must agree to the following conditions:

- the registration term is from 1 to 5 years,
- to avoid any deactivation of the domain name, the renewal must be paid and funds cleared **before the Expiration date**,
- provide and maintain accurate, reliable and up-to-date personal contact information,
- names containing two characters followed by two hyphens are not allowed.

"Premium" domain names are subject to specific prices as indicated on Our interface during Your order.

### Section .RADIO.FM.5. Storage of contact information

You consent to the use, copying, distribution, publication in particular in the public [Whois](#) database, modification and other processing of Your personal contact information by BRS Media, CentralNic and data escrow agent designated by BRS Media in accordance with applicable law.

### Section .RADIO.FM.6. Dispute resolution policy

The Registry has adopted the ICANN Uniform Dispute Resolution Policy (UDRP) for .RADIO.FM domains, that You agree fully abide by.

### **Section .RADIO.FM.7. Transfer (change of Registrar)**

The process is started on Our Interface. Before requesting the transfer of the domain, please be sure that You have the domain's authorization code (supplied by Your current Registrar), and that Your domain name:

- does not have a TransferProhibited status,
- does not expire soon (We recommend that you start the transfer request at least one month prior to its Expiration),
- was created at least 60 days prior to the request.

The transfer's completion requires Your confirmation (by e-mail).

Upon successfully transferring a domain, the registration period is extended by one year.

### **Section .RADIO.FM.8. Ownership change**

The ownership change process is available on Our Interface, it requires the confirmation of the two parties by e-mail.

The owner change of a .RADIO.FM domain name does not change the domain's Expiration date.

### **Section .RADIO.FM.9. Deletion process**

**Upon the Expiration of the domain**, We suspend (Hold) the domain name for 44 days, during which time all the associated technical services are deactivated. The late renewal at normal prices is possible during this period.

Then, the domain name is placed in Quarantine status and can be restored, in accordance with the terms and conditions described on Our website and/or as communicated by Our customer service department. The length of the Quarantine period is 35 calendar days.

If the domain is neither renewed nor restored within these

deadlines, the Registry shall place the domain on "Pending Delete" status for several days, and then delete the domain name, which will become available for registration under the "first-come first-served" basis.

### **Section .RADIO.FM.10. Your warranty obligation**

You commit Yourself to indemnify, defend and hold harmless BRS Media, CentralNic and their subcontractors, and the directors, officers, employees, affiliates and agents of each of them, from and against any and all claims, damages, liabilities, costs and expenses, including reasonable legal fees and expenses, arising out of or relating to the registration of Your domain name. This indemnification obligation shall survive the termination of the present contract, whatever may be the cause, and is the direct consequence of Our accreditation agreement.

### **Section .RADIO.FM.11. Actions of the Registry**

You expressly acknowledge and accept that BRS Media reserves the right to deny, cancel, transfer or otherwise make unavailable any domain name that it deems necessary, in its discretion :

- to protect the integrity and stability of the Registry and domain names system,
- to comply with any applicable laws, government rules or requirements, requests of law enforcement, in compliance with any dispute resolution process,
- to avoid any liability, civil or criminal, on the part of BRS Media, as well as its affiliates, subsidiaries or subcontractors, or the officers, directors, representatives, employees, or stockholders of any of them,
- for violations of the present contract or the rules established by BRS Media and CentralNic,
- to correct mistakes made by Registry or any registrar in connection with a domain name registration.

BRS Media also reserves the right to hold or lock a domain name during resolution of a dispute.
