

ANNEX .UK - SPECIAL CONDITIONS FOR THE .UK ccTLD

version 3.1 – July 31st, 2023

In addition to Gandi's [General Terms and Conditions](#) of domain name registration, the registration and use of a domain name in .UK implies the acceptance of and compliance to the present special conditions contained herein.

All Your legal information and contracts can be viewed at any time via Our [website](#). Capitalized terms have the definition attributed to them in our [General Terms and Conditions](#) of domain name registration. Specifically, "You" refers to the owner of the domain name, and "We" designates Gandi.

Section .UK.1. Naming organization

.UK is the official country code Top-Level-Domain (ccTLD) of the United Kingdom.

The following presents the various parties involved and the naming organization for the .UK TLD:

Section .UK.2. Applicable policies

When You apply to register a .UK domain name, You acknowledge that You have fully understood and You have full knowledge of, and You agree to abide by all the rules and specific conditions of .UK domain names, as defined by Nominet, and which may be viewed at the following page:

These rules, that You acknowledge to have fully understood and to have accepted via Our website bind You to the .UK Registry. The present special conditions do not replace these rules, which are incorporated by reference, and are binding on Us and You.

Section .UK.3. Special requirements

.UK, .CO.UK, .ORG.UK and .ME.UK domain names are open to anyone.

Verification procedure

You agree to provide and maintain accurate, reliable and up-to-date personal contact information.

The Registry proceeds to automatic verifications of Your personal data during the registration of Your domain name or when the contact information is modified.

If Your personal data can not be verified by the Registry, the Registry will inform Gandi. Gandi will contact You to request the provision of documents. Failing to provide the documents requested within the deadline given, all Your domain names in .UK and Your account with the Registry will be suspended.

The Registry reserves the right to delete the domain names suspended.

Section .UK.4. Registration term

The registration term is from 1 to 10 years. To avoid any deletion of the domain name, the renewal must be paid, and funds cleared, no later than 30 days after the Expiration date.

Section .UK.6. Storage of contact information

You consent to the collection, use, and publication in the Registry public [Whois](#) database if applicable, modification and other processing of Your personal data by the Registry and its designees and agents for the purposes of providing Registry services and in accordance with the Registry privacy policy.

Section .UK.7. Dispute resolution policy

Nominet has set forth a specific dispute resolution policy for .UK domain names ("UK Dispute Resolution Service" – DRS), that You agree fully abide by:

Section .UK.8. Transfer (change of Registrar)

To proceed to the transfer of a .UK domain name to Gandi, firstly:

- make sure that Your domain name does not have a TransferProhibited status (ClientTransferProhibited status does not prevent to make the transfer via Your registry account), and
- change the IPS tag of the domain name to "GANDI" with Your current Registrar.

Then, You will have to, within 5 days, launch the transfer request on Our interface and make the validation by email.

The transfer does not change the domain's Expiration date.

Section .UK.9. Ownership change

The ownership change process is available on Our interface and requires the confirmation of the current and future holders by email.

The owner change for a .UK domain name does not change the domain's Expiration date.

Section .UK.10. Deletion process

30 days after the Expiration date, the domain name enters in a suspension period for 60 calendar days, during which time all associated technical services are deactivated. Late renewal at normal price is possible during this period.

If the domain is not renewed within these deadlines, the Registry will delete the domain name, which will become available for registration on a "first come first served" basis.
